In the event that I subsequently discover that the deceased person owed the Government of Hong Kong Special Administrative Region or any person any debt or tax, I hereby undertake to settle any claim, which may be lodged by the Government or any claimant against this estate.

8. As all properties beneficially owned by the deceased person as at the date of death are money not exceeding \$50,000.00 in aggregate, I hereby request the Director of Home Affairs to issue a Confirmation Notice to me, certifying that any taking possession or administration of the money set out in the exhibited Schedule of Money by me and any act incidental to such taking possession or administration will not be treated as intermeddling and subject to criminal penalties under section 60J(3), (6) and (7) of the Probate and Administration Ordinance.

9. I will well and truly administer and faithfully dispose of all such property of the deceased person set out in the Schedule of Money.

10. I hereby undertake to give a written notification to the Director of Home Affairs if, subsequently to the issue of the Confirmation Notice, I become –

- (a) aware of any property beneficially owned by the deceased person as at the date of death which has not been disclosed in the Schedule exhibited by this Affidavit;
- (b) aware that the deceased person held any property as trustee or as the manager of a Tso or Tong as at the date of his death; or
- (c) aware of any inaccuracy in the Schedule attached to the Confirmation Notice.

11. I also hereby undertake to surrender the Confirmation Notice to the Director of Home Affairs as soon as practicable if, subsequent to the issue of the Confirmation Notice, I have been notified of the cancellation of the Notice. I understand that failure to do so is an offence under the Probate and Administration Ordinance.
