To submit a copy of valid Certificate of Fire Service Installations and Equipment (FS251) issued by a registered fire service contractor who certified that **all** fire services installations and equipment in the premises (**including Buildings' FSI**) are in efficient working order.

- (2) 呈交由註冊電業工程人員所簽發的有效電力完工證明書 表格 WR1 或 電力規例完工證書 表格 WR2 副本一份以證明處所內的固定電力裝置符合電力條例的規定及操作安全。而該處所:-
 - (i) 凡低壓固定電力裝置允許負載量為超過 100 安培 (單相或三相),該固定電力裝置須安排每 5 年最少作一次檢查、 測試及領取證明書;或

To submit a copy of valid "Work Completion Certificate-Form WR1" or "Periodic Test Certificate-Form WR2" issued by a registered electrical worker (REW) who certified that the Fixed Electrical Installation complies with the Electrical Ordinance and is in safe working order in premises, where:-

- if a low voltage fixed electrical installation located in such premises that has an approved loading exceeding 100A, single or three phase, shall have the installation inspected, tested and certified at least once every 5 year; or
- (ii) if a low voltage fixed electrical installation located in the premises that is used for sleeping accommodation such as the type of hotel, guesthouse, holiday flat and holiday camp shall have the installation inspected, tested and certified at least once every 5 year.
