IMPORTANT NOTES ON APPLICATION FOR  
TRANSFER OF A LICENCE UNDER  
THE BEDSPACE APARTMENT ORDINANCE

1. 有關牌照的轉讓申請，必須由牌照的現時持有人提出。如牌照的持有人無法提出申請，則擬承讓人須就有關床位寓所提交一份新的牌照申請。  
Application for transfer of a Licence should be initiated by the current holder of Licence. If it is not possible for the Licence holder to apply for the transfer, the proposed transferee has to make fresh application for a Licence in respect of the bedspace apartment concerned.
2. 牌照如有遺失，牌照的持有人必須：  
If the Licence is lost, the Licence holder should:
  - (i) 向警方報失；及  
report the loss to the police; and
  - (ii) 向牌照事務處申領該牌照的認證副本，然後才申請轉讓。否則擬承讓人將須就有關床位寓所提交一份新的牌照申請。  
apply to the Office of the Licensing Authority for a certified true copy of the Licence before applying for transfer. Otherwise, the proposed transferee will have to make fresh application for a Licence in respect of the bedspace apartment concerned.
3. 擬承讓人應留意牌照的有效期。如牌照已到期應予續期，只有現時的持有人才可提出申請。  
The proposed transferee should note the expiry date of the Licence. If the Licence is due for renewal, only a current holder may renew.
4. 有關牌照於轉讓後，擬承讓人必須遵行牌照的前任持有人（即轉讓人）（如有任何）就有關床位寓所為領取牌照所遵守的同一套發牌條件。  
Upon transfer of the Licence, the proposed transferee has to comply with the same set of licensing conditions imposed on the previous Licence holder (i.e. the transferor), if any, in respect of the bedspace apartment concerned in order to obtain a licence.
