Each part of the premises to which a permit or licence relates and all seating, fittings and apparatus in the premises, including electrical, cooling, ventilating and other installations, shall be properly maintained such that the safety of persons using the premises will not be adversely affected.
6. **Sanitising facilities for microphones**  
Adequate sanitizing facilities for all microphones shall be provided and maintained in the premises to which a permit or licence relates and the microphones shall be kept in a clean and hygienic condition.
7. **Alterations to layout**  
Except with the prior approval in writing of the licensing authority, no alteration or addition shall be made to the layout of the premises as shown in the plan certified by the licensing authority under Section 4.
8. **Display of permit or licence**  
The permit or licence shall be displayed in a conspicuous position near the entrance of the karaoke establishment in respect of which the permit or licence is granted.
