内地新来港定居人士的统计数字
(二零零九年第三季)

**Home Affairs Department and Immigration Department
Statistics on New Arrivals from the Mainland
(Third Quarter of 2009)**

引言

1. 入境事务处在罗湖边境出入境管制站设有数据搜集机制向所有持单程通行证首次抵港的人士搜集他们的人口及社会特征。
2. 此外，民政事务总署持续在人事登记处—九龙分处向申领身份证的抵港未足一年的十一岁及以上内地新来港人士进行统计调查，旨在找出他们的服务需求及现况。
3. 统计调查收集的资料分析结果分别载列于本报告的第一及第二部分。

涵盖范围

4. 本报告第一部分所载的统计数字，乃根据所有持单程通行证经罗湖边境出入境管制站首次抵港的人士向入境事务处提供的数据编制所得，而第二部分载列的结果则指民政事务总署成功访问内地新来港定居人士的统计调查。这个统计调查的受访对象为在人事登记处—九龙分处申领身份证的抵港未足一年的十一岁及以上内地新来港定居人士。

Introduction

1. A data collection mechanism has been set up by the Immigration Department to collect data on the demographic and social characteristics of one-way permit holders (OWPHs) when they first enter Hong Kong via the Lo Wu control point.
2. In addition, the Home Affairs Department (HAD) conducts a continuous survey on new arrivals from the Mainland aged 11 and above who have arrived in Hong Kong for less than one year when they apply for the Hong Kong Identity Card at the Registration of Persons—Kowloon Office. The HAD survey focuses on the service needs and current situation of the new arrivals from the Mainland.
3. The results of these two surveys are presented in Part 1 and Part 2 of this report respectively.

Coverage

4. Statistics contained in Part 1 of this report are compiled from information provided by all OWPHs to the Immigration Department when they first enter Hong Kong via the Lo Wu Control Point. Findings in Part 2 refer to the successfully interviewed new arrivals in the survey conducted by HAD. The target respondents of this survey are new arrivals from the Mainland aged 11 and above who have arrived in Hong Kong for less than one year when they apply for the Hong Kong Identity Card at the Registration of Persons—Kowloon Office.

5. 在参阅有关数字时，必须留意这两套数字涵盖不同种类的新来港人士，特别是民政事务总署只反映统计调查中受访的十一岁及以上内地新来港定居人士的特征，因此不能与入境事务处统计作直接比较。

主要结果

第一部分：单程通行证持有人的人口及社会特征（详细统计数字载于表一）

数目

6. 在二零零九年第三季共有16 858名单程通行证持有人抵港，平均每日183人。

年龄及性别结构

7. 二零零九年第三季的单程通行证持有人中约20.4%为十五岁以下儿童。这百分比由二零零四年的29.7%下降至二零零八年的24.5%。同期青少年(指十五至二十四岁)的单程通行证持有人比例则增加，这百分比在二零零九年第三季为14.3%。年轻及中年（指二十五至四十四岁）的女性单程通行证持有人的比例则为下跌，由二零零四年的50.4%减少至二零零八年的43.4%；然而，这比例在本季度增加至49.6%。年龄中位数字在二零零四年及二零零九年第三季均维持在29岁。由于近年新来港定居人士的年龄结构有所改变，所以部分的调查结果(*为标记)不能和以往的结果作直接比较。

8. 过去数年女性单程通行证持有人比例均有加減，并在2003年录得最大数值。单程通行证持有人的性别比率由二零零四年的每千名女性相对355名男性增加至二零零八年的466。这比率在二零零九年第三季为382。

5. In reading the figures, it is important to note that the two sets of statistics refer to different groups of new arrivals. In particular, the HAD survey figures only reflect the characteristics of those new arrivals aged 11 and above who responded to the survey and are hence not directly comparable with those covered by the Immigration Department survey.

Major Findings

Part 1: Demographic and Social Characteristics of One-way Permit Holders (Detailed statistics are in Table 1).

Size

6. In Q3 2009, 16 858 OWPHs entered Hong Kong, with a daily average of 183.

Age and Sex Structure

7. About 20.4% of the OWPHs who entered Hong Kong in Q3 2009 were children aged under 15. This percentage has declined from 29.7% in 2004 to 24.5% in 2008. During the same period, there is an increase in the proportion of teenage OWPHs (i.e. those aged 15-24). The figure is reported to be 14.3% in Q3 2009. The proportion of young and middle age (i.e. those aged 25-44) female OWPHs has decreased from 50.4% in 2004 to 43.4% in 2008. However, the proportion increased to 49.6% in the current quarter. The median age remained at 29 in 2004 and in Q3 2009. Since the age structure of new arrivals has changed over the past few years, some of the survey findings (labelled with *) are not directly comparable with those in previous years.

8. The proportion of female OWPHs entering Hong Kong varied over the past few years and recorded a maximum in 2003. The sex ratio of OWPHs increased from 355 males per 1 000 females in 2004 to 466 in 2008. The ratio is reported to be 382 in Q3 2009.

婚姻状况*

9. 由于大部分年轻及中年女性单程通行证持有人为香港男士的妻子，因此十五岁及以上单程通行证持有人中有 84.0% 是曾经结婚。除却部份数字有季节性变动，曾经结婚的单程通行证持有人百分比在二零零四年至二零零九年第三季均维持在 80% 或以上。

教育程度*

10. 在二零零九年第三季，十五岁及以上单程通行证持有人曾接受中学教育及大专或以上教育的比例，分别是 74.8% 及 14.0%。值得注意的是教育程度在大专或以上的单程通行证持有人在过去数年有所改善；曾接受中学教育的人士由二零零四年的 75.0% 轻微下跌至二零零九年第三季的 74.8%，同期曾接受大专或以上教育的比例则由 10.5% 增至 14.0%。

经济活动身分 / 内地从事行业*

11. 与二零零四年比较，曾在内地工作的十五岁及以上单程通行证持有人的比例在过去数年均为增加，这百分比在二零零四年和二零零九年第三季分别为 26.1% 及 31.7%。这表示在内地没有工作的比例占二零零九年第三季单程通行证持有人的 68.3%，当中大部分是料理家务者及学生。

12. 在二零零九年第三季曾在内地工作的单程通行证持有人中，15.7% 从事文员及售货员的工作，另外 15.6% 则是农民、猎人及渔人。

原籍省份

13. 大部分的单程通行证持有人原籍广东省，有关比例在二零零四年及二零零九年第三季分别为 62.9% 及 58.7%。

Marital Status *

9. 84.0% of the OWPHs aged 15 and above were or had been married as most of the young and middle age female OWPHs were wives of Hong Kong men. Other than the variations in certain quarterly statistics, the proportion of OWPHs who were or had been married remained 80% and above throughout 2004 to Q3 2009.

Educational Attainment *

10. In Q3 2009, 74.8% and 14.0% of OWPHs aged 15 and above had attained secondary education and post-secondary education or above respectively. It is worth noting that OWPHs with post-secondary education or above has improved over the years. The percentage of OWPHs who have received secondary education decreased slightly from 75.0% in 2004 to 74.8% in Q3 2009. During the same period, the proportion of those who have attained post-secondary education has increased from 10.5% to 14.0%.

Activity Status / Occupation in the Mainland *

11. The proportion of OWPHs aged 15 and above who had worked on the Mainland increased in the past few years when compared with that in 2004. The percentage is reported to be 26.1% and 31.7% in 2004 and Q3 2009 respectively. In Q3 2009, 68.3% of the OWPHs have not worked on the Mainland. Most of them were homemakers and students.

12. Among those OWPHs who worked on the Mainland in Q3 2009, 15.7% were clerical and sales staff; 15.6% were farmers, hunters and fishermen.

Province of Origin

13. The majority of OWPHs came from the Guangdong Province. The proportion is reported to be 62.9% and 58.7% in 2004 and Q3 2009 respectively.

能否说广东话

14. 在二零零九年第三季，81.5% 的单程通行证持有人能说广东话。这可能是与单程通行证持有人是来自广东省有关。

在港亲属类别*

15. 单程通行证计划的实施是为方便内地人士来港作家庭团聚。单程通行证持有人只有父/母在港的比例由二零零四年的43.5%减少至二零零九年第三季的34.3%，同期只有配偶在港的比例则由17.9%增加至29.6%，而有父母、配偶和/或子女在港的组合比例则由36.0%减少至34.8%。另外在二零零九年第三季有0.9%单程通行证持有人为只有子女在港者。

有否居留权证明书*

16. 在二零零九年第三季，9.2%的单程通行证持有人同时持有居留权证明书。二零零四年的数字为27.1%。

第二部分：内地新来港定居人士的服务需求及现况（详细统计数字列于表二）

受访人数及回应率

17. 在二零零九年第三季民政事务总署的统计调查访问了10 010名内地新来港定居人士。在同期内共有14 634名十一岁及以上单程通行证持有人抵港，响应率为68.4%。由于新来港人士的抵港日期和申请身份证日期有差异，读者请注意响应率只是一个代指标。

Ability to Speak Cantonese

14. In Q3 2009, 81.5% of OWPBs were able to speak Cantonese. This may be related to Guangdong being their province of origin.

Type of Relatives in Hong Kong *

15. The One-way Permit Scheme was implemented to enable Mainlanders to come to Hong Kong for family reunion. The proportion of OWPBs with only parent(s) in Hong Kong has decreased from 43.5% in 2004 to 34.3% in Q3 2009 and those with only spouse in Hong Kong has increased from 17.9% in 2004 to 29.6% in Q3 2009. The proportion of OWPBs with a combination of parents, and/or spouse and/or children in Hong Kong decreased from 36.0% to 34.8% during the same period. There was another 0.9% of OWPBs in Q3 2009 who had only children in Hong Kong.

Whether with Certificate of Entitlement *

16. In Q3 2009, 9.2% of OWPBs entered Hong Kong with Certificates of Entitlement, as compared with 27.1% in 2004.

Part 2: Service Needs and Current Situation of New Arrivals from the Mainland (Detailed statistics are in Table 2)

Number of Respondents and Response Rate

17. 10 010 new arrivals from the Mainland responded to the HAD survey in Q3 2009. When compared with the number of OWPBs aged 11 and above who entered Hong Kong (14 634) in the same period, the response rate was 68.4%. Readers are cautioned that the response rate is only a proxy indicator because there is a time gap between the respondents arrive in Hong Kong and they apply for a Hong Kong Identity Card.

在港居住地区

18. 二零零九年第三季最多受访者在港居住的三个地区包括观塘 (11.4%)、深水埗 (11.1%) 和葵青 (8.1%)。而居住在观塘及深水埗的受访者比例由二零零四年至二零零九年第三季期间均很高。

适应困难*

19. 表示适应香港生活有困难的受访者比例在二零零九年第三季为 73.2%。自二零零四年开始, 有关比例均维持在 68% 及以上。而在二零零九年第三季的受访者中, 其最大困难是工作 (48.1%), 其次是居住环境 (34.0%)。

支持服务*

20. 受访者中需要支持服务的比例在二零零九年第三季有 78.8%, 较二零零四年的 71.7% 增加。而其中需求最大的是寻找工作方面的协助 (56.8%), 其次是申请租住公共房屋 (37.1%)。

在香港就业打算*

21. 表示希望在香港工作的受访者比例在二零零四年和二零零九年第三季分别为 47.2% 及 51.9%。他们主要希望从事批发、零售、进出口贸易、饮食及酒店业。

家庭人数

22. 于二零零九年第三季, 超过一半受访者居住在3人住户及4人住户。居住在3人住户的受访者百分比由二零零四年的 39.5% 增加至二零零九年第三季的 44.8%; 在同期居住在4人住户的受访者比例由 21.6% 增加至 26.8%。

District of Residence in Hong Kong

18. The three districts where most respondents in Q3 2009 resided in were Kwun Tong (11.4%), Sham Shui Po (11.1%) and Kwai Tsing (8.1%). The proportion of respondents living in Kwun Tong and Sham Shui Po has been considerably high from 2004 to Q3 2009.

Difficulties in Adapting *

19. In Q3 2009, 73.2% of respondents reported having difficulties in adapting to life in Hong Kong. The proportion had remained 68% and above since 2004. The greatest difficulty encountered by respondents in Q3 2009 was employment (48.1%), followed by living environment (34.0%).

Supporting Services *

20. The proportion of respondents who needed supporting services has increased from 71.7% in 2004 to 78.8% in Q3 2009. The most needed service was assistance in seeking employment (56.8%), followed by application for public housing (37.1%).

Employment Plan in Hong Kong *

21. The proportion of respondents who wished to work in Hong Kong is reported to be 47.2% and 51.9% in 2004 and Q3 2009 respectively. Most of them preferred to work in the wholesale, retail, import/export trades, restaurants and hotels sectors.

Family size

22. Over half of the respondents lived in 3-person or 4-person households in Q3 2009. The percentage of respondents living in 3-person households has increased from 39.5% in 2004 to 44.8% in Q3 2009. The proportion of those living in 4-person households has increased from 21.6% to 26.8% during the same period.

居住状况

23. 单程通行证持有人大部分是来港作家庭团聚，因此二零零九年第三季的受访者中有88.1%与家庭成员同住，另有11.5%与家庭成员住在亲友家中。二零零四年的相应数字分别是89.3%和5.0%。

现居房屋由谁提供

24. 在二零零九年第三季，75.0%受访者的现居是由自己或家庭成员租住。此外11.7%的住所是由亲友提供的。二零零四年的相应数字分别是70.3%及10.1%。

房屋类型

25. 在二零零九年第三季，以居于公营租住房屋的受访者占多数（48.5%），其次是私人永久性房屋（40.6%）。

家庭每月收入

26. 受访者的家庭每月入息中位数由二零零四年的港币6,900元增加至二零零九年第三季的港币7,700元。

主要收入来源

27. 以工资为主要收入来源的受访者的百分比由二零零四年的72.4%增加至二零零九年第三季的84.1%，而同期间依靠亲友援助的则由6.5%下跌至2.3%，而依靠政府援助的百分比则由14.3%下调至10.4%。

Present living conditions

23. Since most OUPHs came to Hong Kong for family reunion, 88.1% of the respondents in Q3 2009 lived with family members. Another 11.5% lived with family members in their relatives' places. The corresponding figures in 2004 were 89.3% and 5.0% respectively.

Provision of housing

24. In Q3 2009, 75.0% of the respondents reported that their current accommodation was either rented by themselves or their family members. Another 11.7% lived in accommodation provided by their relatives/friends. The corresponding figures in 2004 were 70.3% and 10.1% respectively.

Type of Housing

25. In Q3 2009, the most common type of housing occupied by respondents was public rental housing (48.5%), followed by private permanent housing (40.6%).

Monthly Family Income

26. The median monthly family income for respondents has increased from HK\$6,900 in 2004 to HK\$7,700 in Q3 2009.

Main source of income

27. The percentage of respondents who reported that wages constituted their major source of income has increased from 72.4% in 2004 to 84.1% in Q3 2009. The percentage of respondents relying on relatives' assistance has decreased from 6.5% to 2.3% and the percentage of respondents relying on Government's assistance decreased from 14.3% to 10.4% during the same period.
