

目的

受惠對象

必須符合以下所有條件 -

1. 持單程通行證從內地來港定居未滿 7 年。
2. 來自低收入家庭，即 —

(a) 平均每月家庭入息低於下列指定入息限額 或

(b) 申請人或其家庭成員 * 已通過下列其中一項特定資助計劃的經濟審查 -

- i. 綜合社會保障援助計劃；
- ii. 學生資助辦事處轄下學生資助計劃；
 - 資助專上課程學生資助計劃；
 - 專上學生資助計劃；
 - 中、小學生資助計劃 (即學校書簿津貼計劃、學生車船津貼計劃、上網費津貼計劃、考試費減免計劃、毅進計劃 (全額學費發還) 或指定夜間成人教育課程資助計劃 (全額 / 半額學費發還))；
 - 幼稚園及幼兒中心學費減免計劃；
- iii. 醫院管理局醫療費用減免機制 (不包括「一次性有效費用減免」)。

* 家庭成員指同住的父、母、子、女、夫或妻 (在法律上獲承認的領養父母子女關係，或非婚生子女而能出示證明有關父母子女關係的也涵蓋在內)。

3. 為非在學人士。

4. 參加僱員再培訓局指定的特定服務對象語文課程，並在有關課程出席率達 80% 或以上。(僱員再培訓

局指定的特定服務對象語文課程已列於申請表內的申請指引附錄一)

5. 一年內只可申請課程津貼兩次，及三年內最多只可申請四次。

Objectives

To provide subsidy for non-school-attending new arrivals from the Mainland (NAs) participating in specified language courses of the Employees Retraining Board (ERB) to encourage NAs from different backgrounds to engage in life-long learning and to enhance personal abilities.

Target Beneficiaries

Should meet all of the following criteria:

1. Have entered Hong Kong from the Mainland on One-way Permit and resided in Hong Kong for less than 7 years.

2. From low-income families:

- (a) with an average monthly household income below the following specified income limit or

(The specified income limit will be subject to updates, please refer to the Home Affairs Department's website: www.had.gov.hk for details.)

- (b) the applicant or his/her family member* has passed the means-test of any one of the following specified assistance schemes:

- Comprehensive Social Security Assistance Scheme;
- Student financial assistance schemes under the Student Financial Assistance Agency;
 - Tertiary Student Finance Scheme - Publicly-funded Programmes;
 - Financial Assistance Scheme for Post-secondary Students;
 - Financial Assistance for Primary and Secondary Students (i.e. the School Textbook Assistance Scheme, Student Travel Subsidy Scheme, Subsidy Scheme for Internet Access Charges, Examination Fee Remission Scheme), Project Yi Jin (full fee reimbursement) or Financial Assistance Scheme for Designated Evening Adult Education Courses (full/half fee reimbursement);
 - Kindergarten and Child Care Centre Fee Remission Scheme;
- Hospital Authority Medical Fee Waiving Mechanism (excluding one-off waiver).

* Family member refers to father, mother, son, daughter, husband or wife residing with the applicant (including legally recognized adoptive parents/children and illegitimate children with proof of parentage).

3. Non-school-attending participants.

4. Participating in specified language courses for special target groups of the ERB with 80% attendance or above. (Please refer to the "Notes to Applicants" attached to the application

form for the list of the specified language courses for special target groups of the ERB)

5. Can only apply for the subsidy twice per year and no more than four times in three years.
