#### 填寫監察點票代理人委任通知書說明

### **Notes on Completion of Notice of Appointment of Counting Agents**

- 1. 在這通知書及說明中,在文意許可的情況下,"他"是指"他"或"她"。 In this notice and these notes, "he" means "he" or "she" as far as the context permits.
- 2. 除非候選人以指明表格明文另作示明,有關代理人須當作是為在預定日期進行的投票中或(如適用的話)遭押 後的該次投票中所投的票的點算而委任。

The agent is to be regarded as being appointed for the counting of the votes cast in the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.

- 3. 根據《選舉程序(鄉郊代表選舉)規例》(第 541 章,附屬法例 L)第 2 條,"點票站"包括選票分流站。 According to section 2 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), "counting station" includes a ballot paper sorting station.
- 4. 根據《選舉程序(鄉郊代表選舉)規例》(第 541 章,附屬法例 L)第 2 條,"點票"包括將選票分開、分類和點算。

According to section 2 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), "counting of the votes" includes separation, sorting and counting of ballot papers.

5. 村代表選舉的候選人或其選舉代理人可**委任不超過 2 名監察點票代理人**,而街坊代表選舉的候選人或其選舉代理人則只可**委任 1 名監察點票代理人**。凡年滿 18 歲的香港身分證持有人均可被委任為監察點票代理人。候選人或其選舉代理人不應委任選舉主任、助理選舉主任、或任何已受民政事務總署委任協助進行投票或點票的人士(通常為政府公職人員)為其監察點票代理人。

For Village Representative Election, a candidate or his election agent <u>may appoint not more than 2 counting agents</u>. For Kaifong Representative Election, a candidate or his election agent <u>may only appoint 1 counting agent</u>. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a counting agent. However, a candidate or his election agent should ensure that he does not appoint as his counting agent the Returning Officer, Assistant Returning Officer, or any person (usually a government officer) already appointed by the Home Affairs Department to assist at the poll or at the count.

- 6. 本通知書的第一部分應由候選人或選舉代理人填寫及簽署。第二部分應由各個監察點票代理人填寫及簽署。 Part I of the notice should be completed and signed by the candidate or the election agent. Part II should be completed and signed by each of the counting agents.
- 7. 委任監察點票代理人的委任通知書,須於<u>投票日 3 天前藉專人送遞、郵遞、電子郵件或圖文傳真方式送交有關的選舉主任,或於投票日由候選人或選舉代理人親自向有關的選舉主任遞交。逾期遞交的通知將不予接納。監</u>察點票代理人的委任,在選舉主任接獲委任通知書後始生效。

Notice of appointment of counting agents shall either be delivered to the relevant Returning Officer by hand, by post, by electronic mail or by facsimile transmission before the 3 days preceding polling day, or be given by the candidate or the election agent in person to the Returning Officer concerned on the polling day. Late submissions will not be accepted. The appointment of counting agents will not be effective until the notice of appointment is received by the Returning Officer.
