I declare that I am not disqualified from being nominated as a candidate at the above election, or from being elected as an Indigenous Inhabitant Representative for the above-mentioned Village by reason of the provisions of section 23 of the Rural Representative Election Ordinance (Cap. 576) or any other law. ## Notes on Completion of Nomination Form for the Rural Representative Election (Indigenous Inhabitant Representative)

以下說明只供參考。有關提名事宜的法例,請參閱《鄉郊代表選舉條例》(第 576 章)、《選舉程序(鄉郊代表選舉)規例》(第 541 章,附屬法例 L)、《選舉(舞弊及非法行為)條例》(第 554 章)及其他有關法例。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation.

- 1. 每份提名表格只能用以提名一位候選人。
  A separate nomination form must be used for each candidate.
- 2. 如候選人選擇公開其職業及任職公司/機構名稱的資料,他/她可在提名表格內申明。
  If a candidate so wishes, he/she can state his/her occupation and name of company/
  organisation on the nomination form.
- 3. 是否提供聯絡資料予傳媒使用屬自願性質。該等資料會提供予傳媒以便他們/她們直接聯絡有關候選人。
  - The supply of contact information for the media is optional. The information will be provided to the media to facilitate them to contact the candidate concerned directly.
- 4. 每份提名表格須由最少5位提名人親自簽署表示同意提名。所有提名人必須已登記為有關原居鄉村/共有代表鄉村的選民。為避免因有提名人不符合資格而令提名失效,提名表格可由多於5位提名人簽署。如超過10位提名人,必須使用提名表格第3頁的補充頁,而第3頁的每張補充頁均須填上由"3(1)"開始的順序頁碼。在遞交提名表格時,表格的每一頁(包括第3頁的所有補充頁)必須一併交予選舉主任。候選人應查證提名人的資格。倘若基於任何原因,某位提名人被發現不符合資格,他/她的提名將不予理會。候選人亦須提醒每位提名人應填寫在其身分證明文件(指提名人記錄在正式選民登記冊內的資料所依據的身分證明文件)上所顯示的姓名。

An nomination form must be personally subscribed and signed by at least 5 subscribers. All the subscribers must be registered electors for the Indigenous Village/Composite Indigenous Village concerned. To avoid the risk of invalidation of the nomination if any subscriber is ineligible, the nomination form may contain more than 5 subscribers. If there are more than 10 subscribers, the supplementary sheet of page 3 of the nomination form must be used. Each sheet of page 3 should be marked with a consecutive serial number starting with "3 (1)". All pages (including all sheets of page 3) of the form must be submitted to the Returning Officer in one complete set. A candidate should check the eligibility of the subscribers. If for any reason a subscriber is found to be ineligible, his/her subscription will be disregarded. A candidate should also remind each of the subscribers to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register).

- 5. 每一位鄉村的選民只可就該村的選舉,在指明數目的提名表格上以提名人身分簽署。指明數目的提名表格是指相等於該村在該選舉中須選出的原居民代表數目的提名表格。 An elector for a Village is entitled to subscribe the specified number of nomination forms only. The specified number of nomination forms means the number of nomination forms that is equivalent to the number of Indigenous Inhabitant Representative(s) to be returned for the Village at the election.

(指候選人記錄在有關鄉村正式選民登記冊內的資料所依據的身分證明文件,通常是其香港身分證)上所顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡體字寫法。未能遵守這項規定會延誤檢查身分證明文件工作及/或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示的姓名有所不同,該候選人可在別名一欄中加上該姓名。提名公告上顯示的候選人姓名(包括別名)會印在選票上。根據《選舉程序(鄉郊代表選舉)規例》(第541章,附屬法例L)第12(1)及(2)條,選舉主任必須將一份關於某人是否獲有效提名的決定的通知,送交該人及有關鄉郊地區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。

For publication of the Notice of Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register for the Village concerned, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name on his/her identity document in Traditional Chinese or Simplified Chinese. Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name (including alias) of the candidate as shown in the Notice of Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the principal residential address(es) of the person(s)/candidate(s) concerned as given on the nomination forms.

- 7. 候選人只有在沒有香港身分證的情況下,才可填寫其他身分證明文件的類別及號碼。 The candidate can provide his/her identity document type and number only if he/she does not have a Hong Kong Identity Card.

A nomination form should be handed in by the candidate <u>in person</u> (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from <u>14 November 2014</u> to <u>27 November 2014</u> (both days inclusive) during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday.

  - A prospective candidate is strongly advised to <u>submit his/her nomination form as early as practicable</u> so that any mistakes found in his/her nomination form can be rectified <u>before the close of nominations</u>.

  The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.

Generally, unless and until the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he/she may hence carry out activities to promote his/her election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

A nomination form will not be valid unless it contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L). The Returning Officer may request such other information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.

A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election/ Kaifong Representative election in this Rural Representative Election. When a candidate hands in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any, or else his/her new nomination will be held to be invalid.

Eligibility for registration as an elector, disqualification for being registered as an elector, disqualifications from voting at an election (including a by-election), qualifications for and disqualifications from being nominated as a candidate or being elected as a Rural Representative are dealt with in sections 14, 15, 16, 22 and 23 of the Rural Representative Election Ordinance (Cap. 576) which are reproduced below for reference —

## When an elector is disqualified from voting at an election (section 14 of the Rural Representative Election Ordinance (Cap. 576))

A person registered as an elector for a Rural Area is disqualified from voting at an election for the Rural Area if the person- (Amended 5 of 2014 s. 2)

- (a) has ceased to be eligible to be so registered;
- (b)-(d) (Repealed 7 of 2009 s. 10)
- (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (f) is a member of the armed forces of the People's Republic of China or any other country or territory.

#### 登記為選民的資格(《鄉郊代表選舉條例》(第576章)第15條)

- (5) 任何人除非符合以下條件,否則沒有資格登記為原居鄉村或共有代表鄉村的選民一

## Who is eligible to be registered as an elector (section 15 of the Rural Representative Election Ordinance (Cap. 576))

- (5) A person is not eligible to be registered as an elector for an Indigenous Village or a Composite Indigenous Village unless the person-
- (a) is an indigenous inhabitant of the Village, or a spouse or surviving spouse of an indigenous inhabitant of the Village;
- (b) is an adult, or will be an adult on or before 20 October next following the person's application for registration; (Amended 12 of 2009 s. 6)
- (c) at the time of applying to be registered, satisfies the Electoral Registration Officer

that the person-

- (i) holds an identity document; or
- (ii) has
  - (A) applied for a new identity card; or
  - (B) requested the alteration of the identity card or the issue of a new identity card, in replacement of the identity card previously issued to the person; and
- (d) at the time of applying to be registered-
  - (i) if the identity document held by, or previously issued to, the person is an identity card, informs the Electoral Registration Officer of the identifying number of the identity card;
  - (ii) if the identity document held by the person is not an identity card, provides the Electoral Registration Officer a copy of the identity document.

## When a person is disqualified from being registered as an elector (section 16 of the Rural Representative Election Ordinance (Cap. 576))

A person is disqualified from being registered as an elector for a Rural Area if the person- (Amended 5 of 2014 s. 2)

- (a)-(c) (Repealed 7 of 2009 s. 11)
- (d) is found under the Mental Health Ordinance (Cap 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (e) is a member of the armed forces of the People's Republic of China or any other country or territory.

## Who is eligible to be nominated as a candidate (section 22 of the Rural Representative Election Ordinance (Cap. 576))

- (2) A person is eligible to be nominated as a candidate at an election for an Indigenous Village or a Composite Indigenous Village only if the person —
- (a) is an indigenous inhabitant of the Village;
- (b) has reached 21 years of age;
- (c) is registered, and eligible to be registered, as an elector for the Village;
- (d) is not disqualified from voting at the election;
- (e) is not disqualified from being nominated as a candidate at the election, or from being elected as an Indigenous Inhabitant Representative for the Village, by virtue of section 23 or any other law;

- (f) is a Hong Kong permanent resident; and
- (g) ordinarily resides in Hong Kong.
- (4) A person is not eligible to be nominated as a candidate at an election for a Rural Area if the person is currently nominated as a candidate at an election for another Rural Area. (Amended 5 of 2014 s. 2)

- (2) 任何人如根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務,即喪失在選舉中獲提名為候選人的資格;但根據本款喪失資格的人如在其後根據該條例獲裁斷為已有能力處理和管理其財產和事務,即有資格在選舉中獲提名為候選人。
- (3) 任何人如根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務,即喪失當選為鄉郊代表的資格;但根據本款喪失資格的人如在其後根據該條例獲裁斷為已有能力處理和管理其財產和事務,即有資格當選為鄉郊代表。(由 2014 年第 5 號第 2 條修訂)

When a person is disqualified from being nominated as a candidate and from being elected as a Rural Representative (section 23 of the Rural Representative Election Ordinance (Cap. 576))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Rural Representative for a Rural Area, if the person- (Amended 5 of  $2014 \, \mathrm{s}.2$ )
- (a) is a judicial officer;
- (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment

- (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
- (ii) received a free pardon<sup>1</sup>;
- (c) has been convicted of treason;
- (d) on the date of nomination, or of the election, is serving a sentence of imprisonment;
- (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted-
  - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine;
  - (ii) of having engaged in corrupt or illegal conduct;

- (g) is a representative or a salaried functionary of the government of a place outside Hong Kong;
- (h) is a member of any national, regional or municipal legislature, assembly or council of a place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national level or local level; or
- (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (2) A person is disqualified from being nominated as a candidate at an election if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection is eligible to be nominated as a candidate at an election if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs.
- (3) A person is disqualified from being elected as a Rural Representative if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection ceases to be disqualified if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs. (Amended 5 of 2014 s. 2)
