Notes on Completion of Nomination Form for the Rural Representative Election (Kaifong Representative)

以下說明只供參考。有關提名事宜的法例,請參閱《鄉郊代表選舉條例》(第 576 章)、《選舉程序(鄉郊代表選舉)規例》(第 541 章,附屬法例 L)、《選舉(舞弊及非法行為)條例》(第 554 章)及其他有關法例。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation.

- 1. 每份提名表格只能用以提名一位候選人。

An nomination form must be **personally subscribed and signed by at least 5 subscribers**. All the subscribers must be registered electors for the Market Town concerned. To avoid the risk of invalidation of the nomination if any subscriber is ineligible, the nomination form may contain more than 5 subscribers. If there are more than 10 subscribers, the supplementary sheet of page 3 of the nomination form must be used. Each sheet of page 3 should be marked with a consecutive serial number starting with "3(1)". All pages (including all sheets of page 3) of the form must be submitted to the Returning Officer in one complete set. A candidate should check the eligibility of the subscribers. If for any reason a subscriber is found to be ineligible, his/her subscription will be disregarded. A candidate should also remind each of the subscribers to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register).

For publication of the Notice of Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register for the Market Town concerned, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name on his/her identity document in Traditional Chinese or Simplified Chinese. Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name (including alias) of the candidate as shown in the Notice of Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the principal residential address(es) of the person(s)/candidate(s) concerned as given on the nomination forms.

A nomination form should be handed in by the candidate <u>in person</u> (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from <u>14 November 2014 to 27 November 2014</u> (both days inclusive) during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday.

A prospective candidate is strongly advised to <u>submit his/her nomination form as early as practicable</u> so that any mistakes found in his/her nomination form can be rectified <u>before the close of nominations</u>.

The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.

10. 一般而言,除非選舉主任決定提名表格無效,否則獲提名的候選人即作為正式獲提名 論,並可展開選舉活動。選舉主任就提名是否有效所作的決定,將為最終決定,除以選 舉呈請提出質疑外,不可循任何法律程序提出質疑。

Generally, unless and until the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he/she may hence carry out activities to promote his/her election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

A nomination form will not be valid unless it contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L). The Returning Officer may request such other information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.

A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Kaifong Representative election in this Rural Representative Election. When a candidate hands in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any, or else his/her new nomination will be held to be invalid.

Eligibility for registration as an elector, disqualification for being registered as an elector, disqualifications from voting at an election (including a by-election), qualifications for and disqualifications from being nominated as a candidate or being elected as a Rural Representative are dealt with in sections 14, 15, 16, 22 and 23 of the Rural Representative Election Ordinance (Cap. 576) which are reproduced below for reference —

- (b)-(d) (由 2009 年第 7 號第 10 條廢除)
- (e) 他根據《精神健康條例》(第136章) 被裁斷為因精神上無行為能力而無能力 處理和管理其財產及事務;或
- (f) 他是中華人民共和國或任何其他國家或地區的武裝部隊的成員。

When an elector is disqualified from voting at an election (section 14 of the Rural Representative Election Ordinance (Cap. 576))

A person registered as an elector for a Rural Area is disqualified from voting at an election for the Rural Area if the person- (Amended 5 of 2014 s. 2)

- (a) has ceased to be eligible to be so registered;
- (b)-(d) (Repealed 7 of 2009 s. 10)

- (f) is a member of the armed forces of the People's Republic of China or any other country or territory.

- (a) is a judicial officer;

 - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
 - (ii) received a free pardon¹;

¹ The Court of First Instance delivered written judgment on 21 June 2012 on Wong Hin Wai v Secretary for Justice (HCAL 51/2012) and Leung Kwok Hung v Secretary for Justice (HCAL 54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (which is similar to section 23(1)(b) of Rural Representative Election Ordinance) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future Rural Representative elections will be organised in accordance with the prevalent electoral laws. Any person who would like to be nominated as a candidate for a Rural Representative election and is doubtful about his/her eligibility for nomination may seek independent legal advice.
