## 填寫撤銷委任代理人通知書說明

### Notes on Completion of Notice of Revocation of Appointment of Agent

1. 候選人可隨時撤銷任何類別的代理人的委任。選舉代理人只可撤銷監察投票代理人或監察點票代理人的委任。  
A candidate may revoke the appointment of any type of agent at any time. An election agent may only revoke the appointment of a polling agent or a counting agent.
2. 就監察投票代理人委任的撤銷，候選人或其選舉代理人必須填上有關被撤銷的投票站名稱。如果某人被撤銷委任為所有投票站的監察投票代理人，請填寫“所有”。  
A candidate or election agent must fill in the name(s) of polling station(s) of which the appointment of a polling agent is to be revoked. If a person's appointment as a polling agent for all the polling stations is to be revoked, please put "ALL".
3. 選舉代理人委任的撤銷在有鄉郊地區的選舉主任接獲撤銷通知書時方生效。  
The revocation of the appointment of an election agent will not be effective until the relevant notice of revocation is received by the Returning Officer for the relevant rural area.
4. 就非位於監獄內的投票站的監察投票代理人委任的撤銷，只可在下列情況下方生效—  
The revocation of the appointment of polling agent(s) for a polling station not situated in a prison will not be effective until the notice of revocation is received by -
  - (a) 有關鄉郊地區的選舉主任於投票當日或之前接獲撤銷委任通知書；或  
the Returning Officer for the relevant rural area on or before polling day; or
  - (b) 有關的投票站主任於投票日接獲由候選人或其選舉代理人親自遞交的撤銷委任通知書。  
the Presiding Officer for the relevant polling station from the candidate or his/her election agent personally on polling day.
5. 就位於監獄內的專用投票站的監察投票代理人委任的撤銷，只可在有關鄉郊地區的選舉主任接獲撤銷委任通知書時方生效。  
The revocation of the appointment of polling agent for a dedicated polling station situated in a prison will not be effective until the notice of revocation is received by the Returning Officer for the relevant rural area.
6. 就監察點票代理人委任的撤銷，只可在下列情況下方生效—  
The revocation of the appointment of counting agent(s) will not be effective until the notice of revocation is received by-
  - (a) 有關鄉郊地區的選舉主任於投票結束前收到撤銷委任通知書；或  
the Returning Officer for the relevant rural area before the close of the poll; or
  - (b) 有關鄉郊地區的選舉主任或助理選舉主任(如屬選票分流站)於投票結束後，收到有關候選人或其選舉代理人親自遞交的撤銷委任通知書。  
The Assistant Returning Officer (if the counting station for which the counting agent is appointed is a ballot paper sorting station) / the Returning Officer (if the counting agent is appointed for a counting station) from the candidate or his election agent personally after the close of the poll.
7. 除上述第 4(b)及 6(b)項另有規定外，填妥的各類代理人的撤銷委任通知書均須藉專人送遞、郵遞、電子郵件或圖文傳真方式交付。若撤銷委任通知於投票日提交，則不可藉郵遞方式交付。代理人委任的撤銷，只可在選舉主任／投票站主任／助理選舉主任(如屬選票分流站)（視何者適用而定）接獲撤銷通知書後方生效。交付代理人的撤銷委任通知書的方式表列如下：  
Subject to Notes 4(b) and 6(b) above, the duly completed notice of revocation of appointment for various types of agents must be delivered by hand, by post, by electronic mail or by facsimile transmission. If the notice of revocation is given on the polling day, it must not be delivered by post. The revocation of appointment is not effective until the notice is received by the Returning Officer/Presiding Officer/Assistant Returning Officer (in case of a ballot paper sorting station), as may be appropriate. The delivery methods of notice of revocation of appointment of agents are summarised below:

(a) **資料用途**

就此通知書提供的個人及其他有關的資料，會供選舉管理委員會、民政事務總署、有關鄉郊地區的選舉主任、選票分流站的助理選舉主任、有關投票站的投票站主任及其他有關的政府部門用於與選舉有關的用途。

**Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, the Home Affairs Department, the Returning Officer for the relevant rural area, the Assistant Returning Officer for the ballot paper sorting station, the Presiding Officers for the relevant polling station(s) and other related government departments for election-related purposes.

(b) **資料轉介**

就此通知書提供的個人及其他有關的資料可能會提供予其他獲授權的部門或人士，包括但不限於法院，用於與選舉有關的用途。

**Transfer of Information**

The personal data and other related information supplied in connection with this notice may be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他／她所提供的個人資料。

**Access to Personal Data**

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**

候選人／選舉代理人在收集第三者的個人資料以填寫此通知書時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的保障資料原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

**Personal Data Protection Principles**

Candidates/Election agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in completing this notice, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorised or accidental access and processing.
