Notes on Completion of Nomination Form for the Rural Representative Election (Resident Representative)

以下說明只供參考。有關提名事宜的法例，請參閱《鄉郊代表選舉條例》(第 576 章)、《選舉(舞弊及非法行為)條例》(第 554 章) 及其他有關法例，包括《選舉程序 (鄉郊代表選舉) 規例》(第 541L 章)。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation, including the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L).

1. 每份提名表格只能用以提名一位候選人。
A separate nomination form must be used for each candidate.
2. 候選人可選擇在提名表格填寫其職業及任職公司／機構名稱的資料，此等資料將會供公眾查閱。候選人的姓名、性別及職業的資料亦會在選舉專用網站發布。
A candidate can choose to state his/her occupation and name of company/organisation in the nomination form, which will be made available for public inspection. Candidate's name, sex and occupation will also be published in the dedicated website of the election.
3. (a) 「通訊地址」只供主要住址未有郵遞服務的人士使用。如你並非所述類別人士，請勿填寫本欄。

The supply of contact information for the media and public inspection is optional. The information will be provided to the media to facilitate them to contact the candidate concerned directly.

A nomination form must be **subscribed and signed personally by at least 5 subscribers. All the subscribers must be registered electors for the relevant Existing Village.** A candidate should not sign as a subscriber in his/her nomination form. To avoid the risk of invalidation of the nomination if any subscriber is unqualified, the nomination form may be subscribed by more than 5 subscribers. If there are more than 10 subscribers, the “Supplementary Sheet for Subscribers” must be used. Each sheet of “Supplementary Sheet for Subscribers” should be marked with a consecutive serial number starting with “Supplementary Sheet (1)”. All pages (including all sheets of “Supplementary Sheet for Subscribers”) of the form must be returned to the Returning Officer in one complete set. A candidate should check the qualification of the subscribers. If for any reason a subscriber is found to be unqualified to subscribe to the nomination form, his/her subscription will be disregarded. A candidate should also remind each subscriber to provide the name as shown

on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register of the relevant Village).

5. 每一位有關現有鄉村的登記選民只可就其所屬的鄉村以提名人身分簽署一份提名表格。
A registered elector in respect of the relevant Existing Village is entitled to subscribe only **ONE** nomination form regarding his/her own Village.

6. 請以中文及英文提供候選人的姓名及主要住址，以便在政府憲報上刊登有效提名公告。有關填寫中文姓名及主要住址的注意事項，可參閱附錄。候選人必須填寫在其身分證明文件（指候選人記錄在有關鄉村正式選民登記冊內的資料所依據的身分證明文件，通常是其香港身分證）上所顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡體字寫法（按情況而定）。未能遵守這項規定會延誤檢查身分證明文件工作及／或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示的姓名有所不同，該候選人可在別名一欄中加上該姓名。有效提名公告上顯示的候選人姓名(包括別名)會印在選票上。根據《選舉程序（鄉郊代表選舉）規例》(第 541L 章) 第 12(1)及(2)條，選舉主任必須將一份關於某人是否獲有效提名的決定的通知，送交該人及有關鄉郊地區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。

Please provide the name and principal residential address of the candidate in both Chinese and English for publication of the Notice of Valid Nominations in the Government Gazette. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register of the relevant Village, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name as shown on his/her identity document in Traditional Chinese or Simplified Chinese (as the case may be). Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name(s) (including alias(es)) of the candidate(s) as shown in the Notice of Valid Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the principal residential addresses of the person/candidate(s) concerned as given on their nomination forms.

7. 提名表格必須在提名期：**2018年11月9日至2018年11月22日內**（首尾兩天包括在內），除公眾假期外的任何日子，於通常辦公時間內（星期一至星期五：上午九時至下午五時；星期六：上午九時至中午十二時）由候選人親自送交給有關的選舉主任（已向選舉主任申請並獲批准以其他方式遞交者除外）。根據《選舉程序（鄉郊代表選舉）規例》(第 541L 章)第 2A(3)條，如提名期的最後一日適逢惡劣天氣警告日(在該工作日中，在通常辦公時間內的任何時間有烈風警告或暴雨警告生效；烈風警告及暴雨警告的涵義與該詞在《司法程序(烈風警告期間聆訊延期)條例》(第 62 章)中的涵義相同)，提名期將會延長至並非惡劣天氣警告日的下一個工作日結束。

A nomination form must be handed in by the candidate **in person** (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from **9 November 2018 to 22 November 2018** (both days inclusive) during ordinary business hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday. According to section 2A(3) of the Electoral Procedure (Rural Representative Election) Regulation (Cap.

541L), if the last day of the nomination period falls on an inclement weather warning day (a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap.62)), the period is extended to end on the next working day which is not an inclement weather warning day.

8. 準候選人應盡早遞交提名表格，以便於提名期結束前，將提名表格上可能發現的錯處更正。

A prospective candidate is strongly advised to submit his/her nomination form as early as practicable so that any mistakes found in his/her nomination form can be rectified before the end of nomination period.

9. 任何提名表格所載候選人姓名或其他重要資料如經更改，將可能不被選舉主任接納。

The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.

10. 選舉主任就提名是否有效所作的決定，除以選舉呈請提出質疑外，不可循任何法律程序提出質疑。

The Returning Officer's decision on the validity of a nomination cannot be questioned in any proceeding except by an election petition.

11. 提名表格必須按《鄉郊代表選舉條例》(第 576 章)及《選舉程序(鄉郊代表選舉)規例》(第 541L 章)的規定列載所需的資料，提名方才有效。在決定候選人是否合乎資格及其提名有效與否時，有關的選舉主任可要求候選人提供其認為需要的額外資料。

A nomination will not be valid unless the nomination form contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L). The Returning Officer concerned may request such additional information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.

12. 候選人不得在是次鄉郊代表選舉中在超過一個鄉郊地區獲得提名；亦不可同時參選原居民代表及居民代表的選舉。候選人遞交提名表格時，必須已撤回在是次鄉郊代表選舉中所有其他鄉郊地區的參選提名(如有)，否則，他/她其後的提名將被當作無效。

A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election in this Rural Representative Election. When he/she submits his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any. Otherwise, his/her subsequent nomination(s) will be treated as invalid.

13. 候選人如欲退出選舉，可填寫一份「候選人退選通知書」的指明表格(HAD/C5)，並於提名期結束前送遞予有關的選舉主任。

If a candidate wishes to withdraw his/her candidature, he/she may do so by completing and delivering to the Returning Officer concerned a "Notice of Withdrawal of Candidature" in a specified form (HAD/C5) before the end of nomination period.

14. 本提名表格第二部分必須於見證人在場下由候選人填寫及簽署。任何年滿 18 歲並持有身分證明文件的人士均可擔任見證人。見證人必須填寫及簽署本提名表格第三部分。根據《鄉郊代表選舉條例》(第 576 章)第 2(1)條，“身分證明文件”(identity document)指—

PART II of this nomination form should be completed and signed by a candidate in the presence of a witness who can be any person in possession of an identity document and aged 18 years or over. The witness is required to complete PART III of this nomination form and sign thereunder. According to section 2(1) of the Rural Representative Election Ordinance

(Cap. 576), “identity document” (身分證明文件) means –

- (a) 身分證；或
an identity card; or
- (b) 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。

- (b)-(d) (Repealed 7 of 2009 s. 10)
- (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (f) is a member of the armed forces of the People’s Republic of China or any other country or territory.

A person is disqualified from being registered as an elector for a Rural Area if the person – (Amended 5 of 2014 s. 2)

- (a)-(c) (Repealed 7 of 2009 s. 11)
- (d) is found under the Mental Health Ordinance (Cap 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (e) is a member of the armed forces of the People's Republic of China or any other country or territory.

being elected as a Resident Representative for the Village, by virtue of section 23 or any other law.

- (4) A person is not eligible to be nominated as a candidate at an election for a Rural Area if the person is currently nominated as a candidate at an election for another Rural Area. (Amended 5 of 2014 s. 2)

When a person is disqualified from being nominated as a candidate and from being elected as a Rural Representative (section 23 of the Rural Representative Election Ordinance (Cap. 576))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Rural Representative for a Rural Area, if the person— (Amended 5 of 2014 s. 2)
 - (a) is a judicial officer;
 - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not—
 - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
 - (ii) received a free pardon¹;
 - (c) has been convicted of treason;
 - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment;
 - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person’s conviction, is or has been convicted—
 - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine;
 - (ii) of having engaged in corrupt or illegal conduct;
 - (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (iv) of any offence prescribed by the EAC Regulations;
 - (f) is ineligible to be a candidate at the election, or to be elected as a Rural Representative for the Rural Area, because of the operation of this Ordinance or any other law; (Amended 5 of 2014 s. 2)
 - (g) is a representative or a salaried functionary of the government of a place outside Hong Kong;
 - (h) is a member of any national, regional or municipal legislature, assembly or council of a place outside Hong Kong, other than a people’s congress or people’s consultative body of the People’s Republic of China, whether established at the national level or local level; or
 - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person’s creditors, in either case without paying the creditors in full.
- (2) A person is disqualified from being nominated as a candidate at an election if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection is eligible to be nominated as a candidate at an election if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs.
- (3) A person is disqualified from being elected as a Rural Representative if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection ceases to be disqualified if it is subsequently found under that Ordinance that the person has become capable of managing and

¹ The Court of First Instance delivered written judgment on 21 June 2012 on *Wong Hin Wai v Secretary for Justice* (HCAL 51/2012) and *Leung Kwok Hung v Secretary for Justice* (HCAL 54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (which is similar to section 23(1)(b) of Rural Representative Election Ordinance) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future Rural Representative elections will be organised in accordance with the prevalent electoral laws.
