1. 當收取每項價值 1,000 元以上的選舉捐贈(不論是以金錢、貨物或服務抵付形式)時，候選人必須向捐贈者發出收據，載明捐贈者的姓名或名稱及地址(一如捐贈者所提供的資料)及該項選舉捐贈的詳情。  
On receiving each election donation, of money, goods or service, of more than \$1,000 in value, a candidate must issue to the donor a receipt which specifies the name and address of the donor (as supplied by the donor) and the particulars of the election donation.
2. 選舉捐贈收據的正本應交予捐贈者，副本由候選人保存作記錄。  
The original of the receipt for election donations should be kept by the donor, and a copy should be kept by the candidate for record.
3. 候選人應另製備選舉捐贈收據的副本，以便連同「選舉開支及接受選舉捐贈之申報書及聲明書」(表格編號：HAD/C1/By-E)一併向選舉主任提交。  
The candidate should make copies of receipts for election donations for submission with “Return and Declaration of Election Expenses and Election Donations” (form no.: HAD/C1/By-E) to the Returning Officer.
