Notes on Completion of Notification of Corrected Information
in Relation to Election Advertisements

1. 在這通知書及說明中，在文意許可的情況下，“他”是指“他”或“她”。
In this notification and these notes, "he" means "he" or "she" as far as the context permits.
2. 根據《選舉程序（村代表選舉）規例》（第 541L 章）第 91 條，“發布”是指印刷、展示、展覽、分發、張貼、公布或以任何其他方式使公眾獲知，並包括繼續發布。
According to section 91 of the Electoral Procedure (Village Representative Election) Regulation (Cap. 541L), “publish” means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.
3. 根據《公眾衛生及市政條例》（第 132 章）第 104A 條，“准許”是指私人土地的擁有人或佔用人或政府土地主管當局書面准許候選人展示或張貼招貼或海報的文件。
According to section 104A of the Public Health and Municipal Services Ordinance (Cap.132), “permission” means the written permission of the owner or the occupier of any private land or the authority of any government land for a candidate to display or affix a bill or poster.
4. 根據《選舉（舞弊及非法行為）條例》（第 554 章）第 27 條，“同意書”是指任何人或組織就候選人發布或授權發布收納了該人或組織的姓名、名稱或標識或跟該人或組織有關聯的姓名、名稱或標識；或與該人或組織有關聯的姓名、名稱或標識或與跟該人或組織有關聯的姓名、名稱或標識甚為相似的姓名、名稱或標識；或該人的圖像的選舉廣告的書面同意。
According to section 27 of the Election (Corrupt and Illegal Conduct) Ordinance (Cap. 554), “consent” means the consent in writing by any person or organization for a candidate to publish or authorize the publication of an election advertisement that includes the name or logo of or associated with the person or organization; or a name or logo that is substantially similar to the name or logo of or associated with the person or organization; or a pictorial representation of the person.
5. 候選人必須確保遞交的選舉廣告詳情內容符合《選舉程序（村代表選舉）規例》（第 541L 章）第 92 條及《村代表選舉活動指引》第四章的規定及要求。
The candidate must ensure that the election advertisement particulars submitted complies with the rules and requirements as set out in section 92 of the Electoral Procedure (Village Representative Election) Regulation (Cap. 541L), and Chapter 4 of the “Guidelines on Election-related Activities in respect of the Village Representative Elections”.
6. 在此通知書中提及的選舉廣告，若候選人曾就其內容或類別作出修正，他必須向有關的選舉主任繳存下列資料—
A candidate must deposit with the Returning Officer concerned the following information in respect of any correction to the content or type of election advertisements mentioned in this notification-
 - (a) 每個選舉廣告的印本形式文本 2 份（或就每個實際上不能或不便影印的選舉廣告，提交一式兩張明信片尺寸的彩色相片），以及提供與該選舉廣告有關的准許或同意書的印本形式文本 1 份（如適用）；或
two hard copies each of the election advertisements (or 2 identical postcard sized colour photographs of each election advertisement which cannot be practically or conveniently photocopied) and 1 hard copy each of the relevant permission or consent (if applicable); or
 - (b) 兩份唯讀光碟(CD-ROM)或唯讀型數碼多功能光碟(DVD-ROM)，每份載有相同的選舉廣告，以及提供與該選舉廣告有關的准許或同意書的印本形式文本 1 份（如適用）。
two copies of a CD-ROM or DVD-ROM each containing the identical election advertisements and 1 hard copy each of the relevant permission or consent (if applicable).
7. 所有已修正的資料通知書必須最遲於選舉日後 2 個工作天內（即公眾假期及星期六以外的任何一天內）（即 年 月 日）或在押後的選舉日之後的 2 個工作天內（如適用）向選舉主任繳存。所提交已修正的資料通知書，以及此表格第 1 頁第 1 段所指的「選舉廣告資料摘要」，會一同被作為依據，用以審查和核對候選人的「選舉開支及接受選舉捐贈之申報書及聲明書」（表格編號：HAD/C1/By-E）。
All notification of corrected information must be deposited with the Returning Officer not later than 2 working days (i.e. any day other than a general holiday and Saturday) after the polling day (i.e.) or not later than 2 working days after the postponed or adjourned polling day, where applicable. Any notification of

corrected information so deposited will be used together with the “Information Sheet in Relation to Election Advertisements” referred to in paragraph 1 of page 1 of this form as one of the bases for examining and checking the “Return and Declaration of Election Expenses and Election Donations”(form no.: HAD/C1/By-E) of the candidate.

Please note the following with regard to the personal data supplied in connection with this notification –

(a) **資料用途**

就此通知書提供的個人及其他有關的資料，會供民政事務總署及選舉主任用於與選舉有關的用途。

Purpose of Collection

The personal data and other related information supplied in connection with this notification will be used by the Home Affairs Department and the Returning Officer for election-related purposes.

(b) **資料轉介**

選舉主任收到有關的資料摘要、已修正的資料通知書、准許或授權書、同意書或選舉廣告樣本後，會將副本供公眾查閱。在展示前，表格內所有身分證明文件號碼將會被遮蓋。有關的資料可能會提供予其他獲授權的部門或機構，用於與選舉有關的用途。

Transfer of Information

A copy of the relevant information sheet, notification of corrected information, permission or authorization, consent or election advertisement will be made available by the Returning Officer who has received them for public inspection. All identity document numbers in the form will be covered before display. The information concerned may be provided to other authorized departments/agencies for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他在此通知書所提供的個人資料。

Access to Personal Data

A person has the right to request access to and correction of the personal data he supplied in this notification in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **保障個人資料原則**

請注意，候選人在收集第三者的個人資料以填寫有關表格時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的資料保障原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

Personal Data Protection Principle

The candidate is reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in completing the relevant form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that the personal data are protected against unauthorized or accidental access and processing.
