- (2) 根據《村代表選舉活動指引》第四章,候選人須在發布選舉廣告後的**一個工作天內**,把與選舉廣告 有關的資料/文件,包括准許或同意書的電子文件,上載至中央平台或候選人平台或向選舉主任繳 存印本式文本,以供公眾查閱。
  - In accordance with Chapter 4 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, the candidate should, **within 1 working day** after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate's Platform or deposit a hard copy with the Returning Officer for public inspection.
