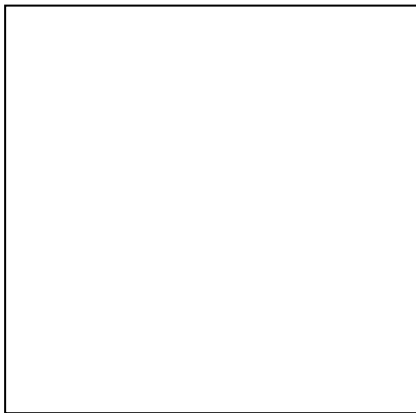

## 說明 Notes

According to section 91 of the Electoral Procedure (Village Representative Election) Regulation (Cap. 541 sub. leg. L), “publish” means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.

(a) **資料用途**

**Purpose of Collection**

The personal data and other related information supplied in connection with this notification will be used by the Home Affairs Department and the Returning Officer for election-related purposes.

(b) **資料轉介**

此通知書會供公眾查閱。在展示前，表格內所有身分證明文件號碼將會被遮蓋。此通知書內的資料可能會提供予其他獲授權的部門或機構，用於與選舉有關的用途。

**Transfer of Information**

This notification form will be made available for public inspection. All identity document numbers in the form will be covered before display. The information provided in this notification may be provided to other authorized departments/agencies for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他所提供的個人資料。

**Access to Personal Data**

A person has the right to request access to and correction of the personal data he supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **保障個人資料原則**
