Notes on Completion of Nomination Form for the Village Representative By-election (Indigenous Inhabitant Representative)

以下說明只供參考。在這說明中,在文意許可的情況下, "他"是指 "他"或 "她"。有關提名事宜的法例,請參閱《村代表選舉條例》(第 576 章)、《選舉 (舞弊及非法行為)條例 》 (第 554 章)及其他有關法例,包括《選舉程序 (村代表選舉)規例》(第 541 章,附屬法例 L)。

The Notes below are for reference only. In these notes, "he" means "he" or "she" as far as the context permits. For legislation concerning nomination matters, please refer to the Village Representative Election Ordinance (Cap. 576), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation, including the Electoral Procedure (Village Representative Election) Regulation (Cap. 541 sub. leg. L).

- 1. 每份提名表格只能用以提名一位候選人。
 A separate nomination form must be used for each candidate.

The supply of contact information for the media is optional. The information will be provided to the media to help them contact the candidates concerned directly.

A nomination form must be **personally subscribed to** and **signed by at least 5 subscribers**. **All the subscribers must be registered electors for the Indigenous Village concerned**. The nomination form may contain more than 5 subscribers to avoid the risk of invalidation of the nomination if any subscriber is disqualified. A candidate should check the eligibility of the subscribers. If for any reason a subscriber is found to be ineligible, his name will be disregarded. A candidate should also remind each of the subscribers to provide the names as shown on their identity documents (being the identity documents based on which the particulars of the subscribers are recorded in the Final Register).

- 4. 每一位鄉村的選民只可就該村的補選,在指明數目的提名表格上以提名人身分簽署。指明數目的 提名表格是指相等於該村在該補選中須選出的村代表數目的提名表格。
 - An elector for a Village is entitled to subscribe the specified number of nomination forms only. The specified number of nomination forms means the number of nomination forms that is equivalent to the number of Indigenous Inhabitant Representative to be returned for the Village at the by-election.

For publication in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate must provide the name as shown on his identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register). If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his identity document, that candidate may include such different name as his alias. The name (including alias) of the candidate as shown in the Notice of Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Village Representative Election) Regulation (Cap. 541 sub. leg. L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Village concerned. Such a notice must be sent to the principal residential addresses of the person/candidate(s) concerned as given on their nomination

forms.

A nomination form should be handed in by the candidate <u>in person</u> (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from <u>17 April 2014 to 30 April 2014</u> (both days inclusive) during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday.

- 7. 準候選人<u>應盡早遞交提名表格</u>,以便於<u>提名期結束前</u>,將提名表格上可能發現的錯處更正。 A prospective candidate is strongly advised to <u>submit his nomination form as early as practicable</u> so that any mistakes found in his nomination form can be rectified <u>before the close of nominations</u>.
- 8. 任何提名表格所載候選人姓名或其他重要資料如經更改,將可能不被選舉主任接納。
 The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.
- 9. 一般而言,除非選舉主任決定提名表格無效,否則獲提名的候選人即作為正式獲提名論,並可展開選舉活動。選舉主任所作的決定,將為最終決定,除以選舉呈請提出質疑外,不可循任何法律程序提出質疑。

Generally, unless and until the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he may hence carry out activities to promote his election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

A nomination form will not be valid unless it contains the information as required in the Village Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Village Representative Election) Regulation (Cap. 541 sub. leg. L). The Returning Officer may request such other information from a candidate as he considers necessary to satisfy himself as to the eligibility of the candidate and the validity of the nomination.

11. 現任村代表不得在今次補選中接受提名。
An incumbent Village Representative cannot be nominated at the by-election.

12. 候選人不得在是次村代表補選中在超過一條鄉村接受提名;亦不可同時參選原居民代表及居民代表的補選。候選人遞交一份提名表格時,必須已退出在所有其他鄉村的補選,否則,其新的提名將會當作無效。

A candidate cannot be nominated for more than one Village and cannot stand for both Indigenous Inhabitant Representative By-election and Resident Representative By-election in this Village Representative By-election. When he hands in his nomination form, he must have withdrawn his candidature in respect of all other Villages, if any, or else his new nomination will be held to be invalid.

If a candidate wishes to withdraw his candidature, he may do so by completing and delivering to the Returning Officer concerned a "Notice of Withdrawal of Candidature" in a specified form (form no. HAD/C5/By-E) before the close of nominations.

witness who can be any person in possession of a valid identity document and aged 18 years or over. The witness is required to complete Part III of this form and sign thereunder. According to section 2(1) of the Village Representative Election Ordinance (Cap. 576), "identity document" (身分證明文件) means—

Disqualifications from voting at an election (including a by-election), qualifications and disqualifications from being nominated as a candidate or from being elected as a Village Representative are dealt with in sections 14, 22 and 23 of the Village Representative Election Ordinance (Cap. 576) which are reproduced below for reference —

第14條:選民喪失在選舉中投票的資格的情況

已登記為某鄉村的選民的人如有以下情況,即喪失在該村選舉中投票的資格 -

- (a) 他已不再有資格如此登記;
- (b) 他根據《精神健康條例》(第136章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務;或
- (c) 他是中華人民共和國或任何其他國家或地區的武裝部隊的成員。

Section 14 When an elector is disqualified from voting at an election

A person registered as an elector for a Village is disqualified from voting at an election for the village if the person —

- (a) has ceased to be eligible to be so registered;
- (b) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (c) is a member of the armed forces of the People's Republic of China or any other country or territory.

- (2) 符合以下條件的人方有資格在原居鄉村或共有代表鄉村選舉中獲提名為候選人—
 - (a) 是該村的原居民;
 - (b) 年滿 21 歳;
 - (c) 已登記並有資格登記為該村的選民;

 - (e) 沒有因第23條或任何其法律喪失獲提名為該選舉的候選人或當選為該村的原居民代表的資格;
 - (f) 是香港永久性居民;及
 - (g) 通常居於香港。
- (4) 任何人如已獲提名為某鄉村的選舉的候選人,則沒有資格同時獲提名為另一鄉村的選舉的候選人。

Section 22 Who is eligible to be nominated as a candidate

- (2) A person is eligible to be nominated as a candidate at an election for an Indigenous Village or a Composite Indigenous Village only if the person
 - (a) is an indigenous inhabitant of the Village;
 - (b) has reached 21 years of age;
 - (c) is registered, and eligible to be registered, as an elector for the Village;
 - (d) is not disqualified from voting at the election;
 - (e) is not disqualified from being nominated as a candidate at the election, or from being elected as an Indigenous Inhabitant Representative for the Village, by virtue of section 23 or any other law;
 - (f) is a Hong Kong permanent resident; and
 - (g) ordinarily resides in Hong Kong.
- (4) A person is not eligible to be nominated as a candidate at an election for a Village if the person is currently nominated as a candidate at an election for another Village.

第23條:喪失獲提名為候選人及當選為村代表的資格的情況

- (1) 任何人如有以下情況,即喪失在選舉中獲提名為候選人的資格及當選為有關鄉村的村代表 的資格 —
 - (a) 他是司法人員;
 - (b) 他已在香港或任何其他地方被判處死刑或監禁 (不論如何稱述),但 -
 - (i) 未服該刑罰或主管當局用以替代該刑罰的其他懲罰;而亦
 - (ii) 未獲赦免¹;
 - (c) 他已被裁定犯叛逆罪;
 - (d) 在獲提名當日或選舉當日,他正因服刑而受監禁;
 - (e) 在不局限 (b) 段的原則下,他被裁定或曾被裁定犯以下罪行,而該選舉於或將於他被 定罪的日期後的 5 年內舉行 —
 - (i) 任何罪行 (不論是在香港或是在任何其他地方被定罪),並就該罪行被判處為期超 逾3個月而又不得選擇以罰款代替的監禁 (不論是否獲得緩刑);
 - (ii) 作出舞弊或非法行為;
 - (iii) 《防止賄賂條例》(第201章) 第II部所訂的罪行;或
 - (iv) 選管會規例所訂明的任何罪行;
 - (f) 他因本條例或任何其他法律的施行而沒有資格在該選舉中擔任候選人或當選為該村的 村代表;
 - (g) 他是香港以外地方的政府的代表或該政府的受薪政府人員;
 - (h) 他是香港以外任何地方的國家級、地區級或市級立法機關、議院或議會 (中華人民共和國的全國或地方人民代表大會或人民協商機構除外)的成員;或
 - (i) 他是未獲解除破產的人,或於過去5年內在沒有向債權人全數償還債務的情況下獲解除破產或與其債權人達成《破產條例》(第6章)所指的自願安排的人。
- (2) 任何人如根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務,即喪失在選舉中獲提名為候選人的資格;但根據本款喪失資格的人如在其後根據該條例獲裁斷為已有能力處理和管理其財產和事務,即有資格在選舉中獲提名為候選人。
- (3) 任何人如根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和 管理其財產及事務,即喪失當選為村代表的資格;但根據本款喪失資格的人如在其後根據 該條例獲裁斷為已有能力處理和管理其財產和事務,即有資格當選為村代表。

¹原訟法庭於 2012 年 6 月 21 日就黃軒瑋訴律政司司長(高院憲法及行政法訴訟 2012 年第 51 號)及梁國雄訴律政司司長(高院憲法及行政法訴訟 2012 年第 54 號)給予書面判詞,裁定《立法會條例》第 39(1)(b)條(與《村代表選舉條例》第 23(1)(b)條相若)違憲。政府當局已於 2012 年 7 月 12 日宣布決定不會就有關判決提出上訴。日後的村代表選舉會按當時生效的法例進行。任何人士如欲在村代表選舉獲提名為候選人,並對他的提名資格有疑問,他可徵詢獨立法律意見。

Section 23 When a person is disqualified from being nominated as a candidate and from being elected as a Village Representative

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Village Representative for a Village, if the person
 - (a) is a judicial officer;
 - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not
 - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
 - (ii) received a free pardon;¹
 - (c) has been convicted of treason;
 - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment;
 - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted
 - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine;
 - (ii) of having engaged in corrupt or illegal conduct;
 - (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (iv) of any offence prescribed by the EAC Regulations;
 - (f) is ineligible to be a candidate at the election, or to be elected as a Village Representative for the Village, because of the operation of this Ordinance or any other law;
 - (g) is a representative or a salaried functionary of the government of a place outside Hong Kong;
 - (h) is a member of any national, regional or municipal legislature, assembly or council of a place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national level or local level; or
 - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (2) A person is disqualified from being nominated as a candidate at an election if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection is eligible to be nominated as a candidate at an election if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs.
- (3) A person is disqualified from being elected as a Village Representative if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection ceases to be disqualified if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs.

¹ The Court of First Instance delivered written judgment on 21 June 2012 on Wong Hin Wai v Secretary for Justice (HCAL 51/2012) and Leung Kwok Hung v Secretary for Justice (HCAL 54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (which is similar to section 23(1)(b) of VRE Ord) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future VR Election will be organised in accordance with the prevalent electoral laws. Any person who would like to be nominated as a candidate for VR Election and is doubtful about his eligibility for nomination may seek independent legal advice where appropriate.
