I hereby declare that I am eligible under section 22 of the Rural Representative Election Ordinance (Cap. 576) to be nominated as a candidate at the above election. In this regard, I provide the following information —

I am a resident of the above-mentioned Village.

(b) 我已年滿 21 歲。

I have reached 21 years of age.

(c) 我是上述鄉村的登記選民，並符合登記成為有關選民的資格。

I am a registered elector for the above-mentioned Village and am eligible to be so registered.

(d) 我並未喪失在選舉中投票的資格。 [見說明第 16 項]

I am not disqualified from voting at the election. [see Note 16]

(e) 我在緊接提名之前的 6 年內一直是有關鄉村的居民。村內住址為我的主要住址，即指我居住的並屬我唯一或主要家居的居住地方的地址。

I have been a resident of the Village for the 6 years immediately preceding the nomination. The residence in the Village is my principal residential address, which means that the address of the dwelling place at which I reside and which constitutes my sole or main home.

I declare that I am not disqualified from being nominated as a candidate at the above election, or from being elected as a Resident Representative for the above-mentioned Village by reason of the provisions of section 23 of the Rural Representative Election Ordinance (Cap. 576) or any other law. I declare that I will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region.

Notes on Completion of Nomination Form for the Rural By-election
(Resident Representative)

以下說明只供參考。有關提名事宜的法例，請參閱《鄉郊代表選舉條例》(第 576 章)、《選舉程序 (鄉郊代表選舉) 規例》(第 541 章，附屬法例 L)、《選舉 (舞弊及非法行為) 條例》(第 554 章) 及其他有關法例。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation.

1. 每份提名表格只能用以提名一位候選人。
A separate nomination form must be used for each candidate.
2. 如候選人選擇公開其職業及任職公司/機構名稱的資料，他/她可在提名表格內申明。
If a candidate so wishes, he/she can state his/her occupation and name of company/organization on the nomination form.
3. (a) 「通訊地址」只供主要住址未有郵遞服務的人士使用。如你並非所述類別人士，請勿填寫本欄。
Please provide a correspondence address only if there is no postal service available for your principal residential address. Please do not fill in this part if you do not meet the said criterion.

A nomination form must be **personally subscribed and signed by at least 5 subscribers. All the subscribers must be registered electors for the Existing Village concerned.** To avoid the risk of invalidation of the nomination if any subscriber is ineligible, the nomination form may contain more than 5 subscribers. If there are more than 10 subscribers, the supplementary sheet of page 3 of the nomination form must be used. Each sheet of page 3 should be marked with a consecutive serial number starting with “3(1)”. All pages (including all sheets of page 3) of the form must be submitted to the Returning Officer in one complete set. A candidate should check the eligibility of the subscribers. If for any reason a subscriber is found to be ineligible, his/her subscription will be disregarded. A candidate should also remind each of the subscribers to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register).
5. 每一位現有鄉村選民只可就該村的選舉，在一張提名表格上簽署。
An elector for an Existing Village is entitled to subscribe ONE nomination form only.
6. 請以中文及英文提供候選人的姓名及主要住址，以便在政府憲報上刊登提名公告。有關

填寫中文姓名及主要住址的注意事項，可參閱附錄。候選人必須填寫在其身分證明文件(指候選人記錄在有關鄉村正式選民登記冊內的資料所依據的身分證明文件，通常是其香港身分證)上所顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡體字寫法。未能遵守這項規定會延誤檢查身分證明文件工作及/或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示的姓名有所不同，該候選人可在別名一欄中加上該姓名。提名公告上顯示的候選人姓名(包括別名)會印在選票上。根據《選舉程序(鄉郊代表選舉)規例》(第541章，附屬法例L)第12(1)及(2)條，選舉主任必須將一份關於某人是否獲有效提名的決定的通知，送交該人及有關鄉郊地區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。

For publication of the Notice of Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register for the Village concerned, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name on his/her identity document in Traditional Chinese or Simplified Chinese. Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name (including alias) of the candidate as shown in the Notice of Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the principal residential address(es) of the person(s)/candidate(s) concerned as given on the nomination forms.

7. 提名表格必須在提名期：**2015年5月5日至2015年5月18日內**（首尾兩天包括在內），除公眾假期外的任何日子，於辦公時間內（星期一至星期五：上午九時正至下午五時正；星期六：上午九時正至正午十二時正）由候選人**親自**送交給有關的選舉主任（已向選舉主任申請並獲批准以其他方式遞交者除外）。

A nomination form should be handed in by the candidate **in person** (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from **5 May 2015 to 18 May 2015** (both days inclusive) during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday.

8. 準候選人應盡早遞交提名表格，以便於**提名期結束前**，將提名表格上可能發現的錯處更正。

A prospective candidate is strongly advised to submit his/her nomination form as early as practicable so that any mistakes found in his/her nomination form can be rectified before the close of nominations.

9. 任何提名表格所載候選人姓名或其他重要資料如經更改，將可能不被選舉主任接納。
The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.

10. 一般而言，除非選舉主任決定提名表格無效，否則獲提名的候選人即作為正式獲提名論，並可展開選舉活動。選舉主任就提名是否有效所作的決定，將為最終決定，除以選舉呈請提出質疑外，不可循任何法律程序提出質疑。

Generally, unless and until the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he/she may hence carry out activities to

promote his/her election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

11. 提名表格必須按《鄉郊代表選舉條例》(第 576 章)及《選舉程序(鄉郊代表選舉)規例》(第 541 章, 附屬法例 L) 的規定列載所需的資料, 方才有效。在決定候選人是否合乎資格及其提名有效與否時, 選舉主任可要求候選人提供其認為需要的額外資料。
A nomination form will not be valid unless it contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L). The Returning Officer may request such other information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.
12. 候選人不得在是次鄉郊補選中在超過一個鄉郊地區接受提名; 亦不可同時參選原居民代表及居民代表的選舉。候選人遞交一份提名表格時, 必須已退出在所有其他鄉郊地區的選舉, 否則, 其新的提名將會當作無效。
A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election in this Rural By-election. When a candidate in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any, or else his/her new nomination will be held to be invalid.
13. 候選人如欲退出選舉, 可填寫一份「候選人退選通知書」的指明表格 (HAD/C5/By-E), 並最遲於提名期結束前送遞予有關的選舉主任。
If a candidate wishes to withdraw his/her candidature, he/she may do so by completing and delivering to the Returning Officer concerned a “Notice of Withdrawal of Candidature” in a specified form (HAD/C5/By-E) before the close of nominations.
14. 本提名表格第二部分必須於見證人在場下由候選人填寫及簽署。任何年滿 18 歲並持有有效身分證明文件的人士均可擔任見證人。見證人必須填寫及簽署本提名表格第三部分。根據《鄉郊代表選舉條例》(第 576 章)第 2(1)條, “身分證明文件”(identity document) 指—
Part II of this nomination form should be completed and signed by a candidate in the presence of a witness who can be any person in possession of a valid identity document and aged 18 years or over. The witness is required to complete Part III of this form and sign thereunder. According to section 2(1) of the Rural Representative Election Ordinance (Cap. 576), “identity document” (身分證明文件) means –
 - (a) 身分證; 或
an identity card; or
 - (b) 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.

16. 根據《鄉郊代表選舉條例》(第 576 章)第 14、15、16、22 及 23 條, 有關登記為選民的資格、喪失登記為選民的資格、選民喪失在選舉(包括補選)中投票的資格、獲提名為候選人的資格及喪失獲提名為候選人或當選為鄉郊代表的資格的規定如下, 以作參考—

Eligibility for registration as an elector, disqualification for being registered as an elector, disqualifications from voting at an election (including a by-election), qualifications for and disqualifications from being nominated as a candidate or being elected as a Rural Representative are dealt with in sections 14, 15, 16, 22 and 23 of the Rural Representative Election Ordinance (Cap. 576) which are reproduced below for reference —

選民喪失在選舉中投票的資格的情況〔《鄉郊代表選舉條例》(第576章)第14條〕

已登記為某鄉郊地區的選民的人如有以下情況，即喪失在該地區的選舉中投票的資格 — (由2014年第5號第2條修訂)

- (a) 他已不再有資格如此登記；
- (b)-(d) (由2009年第7號第10條廢除)
- (e) 他根據《精神健康條例》(第136章)被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務；或
- (f) 他是中華人民共和國或任何其他國家或地區的武裝部隊的成員。

When an elector is disqualified from voting at an election (section 14 of the Rural Representative Election Ordinance (Cap. 576))

A person registered as an elector for a Rural Area is disqualified from voting at an election for the Rural Area if the person- (Amended 5 of 2014 s. 2)

- (a) has ceased to be eligible to be so registered;
- (b)-(d) (Repealed 7 of 2009 s. 10)
- (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (f) is a member of the armed forces of the People's Republic of China or any other country or territory.

登記為選民的資格〔《鄉郊代表選舉條例》(第576章)第15條〕

(4) 任何人除非符合以下條件，否則沒有資格登記為現有鄉村的選民—

- (a) 他是該村的居民；
- (b) 他在緊接申請登記當日之前的3年內一直是該村的居民；

 - (ii) received a free pardon¹;
 - (c) has been convicted of treason;
 - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment;
 - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted-
 - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine;
 - (ii) of having engaged in corrupt or illegal conduct;

¹ The Court of First Instance delivered written judgment on 21 June 2012 on Wong Hin Wai v Secretary for Justice (HCAL 51/2012) and Leung Kwok Hung v Secretary for Justice (HCAL 54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (which is similar to section 23(1)(b) of Rural Representative Election Ordinance) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future Rural Representative elections will be organised in accordance with the prevalent electoral laws.
