6. *我／我們每人均清楚明白，*我／我們須事先作出保密聲明，並於投票當日到達點票站後，在點票進行前，向選舉主任報到時出示該保密聲明及*我／我們之香港身分證。
*I/Each of us clearly understand(s) that *I/we must make a Declaration of Secrecy in advance and produce such Declaration of Secrecy and *my/our Hong Kong Identity Card(s) when reporting to the Returning Officer on attending the counting station before commencement of the count on the polling day.

divulge any information obtained at the counting of the votes including the candidate(s) for whom a vote has been given on any particular ballot paper;
 - (b) 觸摸選票、或將選票分開或排列；
handle, separate or arrange ballot papers;
 - (c) 干擾或企圖干擾任何投票箱、選票結算書、選票結算核實書或覆核書、或其他有關的選舉物料；或
interfere with or attempt to interfere with any ballot boxes, ballot paper accounts, verifications or re-verifications of such accounts or other relevant election materials; or
 - (d) 在點票過程拍影片、拍照、錄音或錄影。
take film, photograph or make any audio or video recording during the sorting or counting process.

8. *我／我們每人均清楚明白，倘*我／我們在點票站內或其鄰近範圍內行為不檢，或不服從選舉主任的任何合法指示，即屬違法，可被判罰款及監禁，並可能會被選舉主任命令立即離開該地方。倘*我／我們沒有離開，可能會被警務人員或獲選舉主任以書面授權的人員逐離該地方。*我／我們被逐離後，除非獲得選舉主任的許可，否則不得再次進入點票站。

*I/Each of us also clearly understand(s) that if *I/we misconduct *myself/ourselves at or in the vicinity of the counting station, or fail to obey any lawful order of the Returning Officer, *I/we shall commit an offence punishable with a fine and imprisonment and may be ordered by the Returning Officer to leave the area immediately. *My/Our failure to leave the area may result in *my/our being removed by a police officer or a person authorized by the Returning Officer in writing. If *I/we are so removed, *I/we may not re-enter the counting station except with the permission of the Returning Officer.

Notes on Completion of Notice of Appointment of Counting Agents

1. 除非候選人以指明表格明文另作示明，有關代理人須當作是為在預定日期進行的投票中或（如適用的話）遭押後的該次投票中所投的票的點算而委任。
The agent is to be regarded as being appointed for the counting of the votes cast in the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.
2. 根據《選舉程序（鄉郊代表選舉）規例》（第 541 章，附屬法例 L）第 2 條，“點票站”包括選票分流站。
According to section 2 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), “counting station” includes a ballot paper sorting station.
3. 根據《選舉程序（鄉郊代表選舉）規例》（第 541 章，附屬法例 L）第 2 條，“點票”包括將選票分開、分類和點算。
According to section 2 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), “counting of the votes” includes separation, sorting and counting of ballot papers.
4. 村代表選舉的候選人或其選舉代理人可**委任不超過 2 名監察點票代理人**，而街坊代表選舉的候選人或其選舉代理人則只可**委任 1 名監察點票代理人**。凡年滿 18 歲的香港身分證持有人均可被委任為監察點票代理人。候選人或其選舉代理人不應委任選舉主任、助理選舉主任、或任何已受民政事務總署委任協助進行投票或點票的人士（通常為政府公職人員）為其監察點票代理人。
For Village Representative Election, a candidate or his election agent **may appoint not more than 2 counting agents**. For Kaifong Representative Election, a candidate or his election agent **may only appoint 1 counting agent**. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a counting agent. However, a candidate or his election agent should ensure that he does not appoint as his counting agent the Returning Officer, Assistant Returning Officer, or any person (usually a government officer) already appointed by the Home Affairs Department to assist at the poll or at the count.
5. 本通知書的第一部分應由候選人或選舉代理人填寫及簽署。第二部分應由各個監察點票代理人填寫及簽署。
Part I of the notice should be completed and signed by the candidate or the election agent. Part II should be completed and signed by each of the counting agents.
6. 委任監察點票代理人的委任通知書，須於投票日 3 天前藉專人送遞、郵遞、電子郵件或圖文傳真方式送交有關的選舉主任，或於投票日由候選人或選舉代理人親自向有關的選舉主任遞交。逾期遞交的通知將不予接納。監察點票代理人的委任，在選舉主任接獲委任通知書後始生效。
Notice of appointment of counting agents shall either be delivered to the relevant Returning Officer by hand, by post, by electronic mail or by facsimile transmission before the 3 days preceding polling day, or be given by the candidate or the election agent in person to the Returning Officer concerned on the polling day. Late submissions will not be accepted. The appointment of counting agents will not be effective until the notice of appointment is received by the Returning Officer.

Purpose of Collection
The personal data and other related information supplied in connection with this notice will be used by the Home Affairs Department and the Returning Officer for election-related purposes.

(b) **資料轉介**

此通知書內的資料可能會提供予其他獲授權的部門或機構，用於與選舉有關的用途。

Transfer of Information

The information provided in this notice may be provided to other authorized departments/agencies for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他所提供的個人資料。

Access to Personal Data

A person has the right to request access to and correction of the personal data he supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **保障個人資料原則**

請注意，候選人在收集第三者的個人資料以填寫有關表格時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的資料保障原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

Personal Data Protection Principle

The candidate is reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in completing the relevant form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access and processing.
