3. 候選人如以電郵方式遞交表格，必須將表格的電子文本夾附於電郵中，**不接受**以其他方式（如提供雲端儲存的超連結）傳送檔案。  
In submission of forms by email, candidates must attach the electronic file of the form to the email. Transmission of files through other methods (e.g. providing a hyperlink of cloud storage) **is not accepted**.

5. 在發布任何選舉廣告後的 3 個工作天（即公眾假期及星期六以外的任何 1 天）內，如候選人打算以印本形式呈交選舉廣告作公眾查閱，他／她必須向有關的選舉主任呈交每個選舉廣告的文本 2 份，以及 1 份與該選舉廣告相關的資料摘要、支持同意書及／或在私人物業展示選舉廣告或進行競選活動的批准書。至於實際上不能或不便以同樣方式出示的選舉廣告，候選人則須呈交每個選舉廣告一式 2 份的全彩色相片／打印本／影印本及 1 份相關的資料摘要、支持同意書及／或在私人物業展示選舉廣告或進行競選活動的批准書。候選人必須確保遞交的選舉廣告詳情符合《選舉程序（鄉郊代表選舉）規例》（第 541L 章）第 92 條及《鄉郊代表選舉活動指引》有關「選舉廣告」的章節的規定及要求。  
If a candidate wishes to submit election advertisements in hard copy format for public inspection, he/she must deposit with the relevant Returning Officer 2 copies each of the election advertisements together with 1 copy of the information sheet, consent of support and/or permission for display of election advertisements or conduct of electioneering activities at private premises within 3 working days (i.e. any day other than a general holiday and Saturday) after publication of any election advertisements. In respect of the election advertisements which cannot be practically or conveniently produced in specie, 2 identical full colour photographs/printouts/photocopies of each election advertisement together with 1 copy of the information sheet, consent of support and/or permission for display of election advertisements or conduct of electioneering activities at private premises must be provided. The candidate must ensure that the election advertisement particulars submitted comply with the rules and requirements as set out in section 92 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L) and the Chapter related to “Election Advertisements” in the “Guidelines on Election-related Activities in respect of the Rural Representative Election”.
6. 欲申請中央平台戶口的候選人須將填妥的中央平台戶口申請表及有關候選人使用中央平台的條款及細則的承諾書(HAD/C10a/By-E)的**正本**送交民政事務總署署長。  
Candidate who would like to or who wishes to apply for an account of the Central Platform should submit the **original** of

the completed Application for Creating an Account of the Central Platform and Undertaking in respect of the Terms and Conditions in Using the Central Platform for Candidates (HAD/C10a/By-E) to the Director of Home Affairs.

7. 任何進入投票站、選票分流站或點票站的人士（包括候選人、選舉代理人、監察投票代理人、監察點票代理人、選舉主任、助理選舉主任、負責投票、選票分流或點票的工作人員、及任何獲授權人士）應在進入投票站、選票分流站或點票站時攜同保密聲明，並於有必要時親自出示以供檢查。

Any person (including candidates, election agents, polling agents, counting agents, Returning Officers, Assistant Returning Officers, officers on polling, ballot paper sorting or counting duties and any other authorized persons) attending a polling station, a ballot paper sorting station or a counting station should bring a Declaration of Secrecy when entering a polling station, a ballot paper sorting station or a counting station and produce it in person for inspection whenever required.

8. 在提交提名表格後，每名候選人可索取正式選民登記冊的摘錄的硬複本及／或軟複本。在確定擬索取的物品後，候選人或選舉代理人必須填妥「索取選民資料通知書」回條，並連同「使用選民資料承諾書」一併以電郵、圖文傳真或郵寄方式交回有關的選舉主任。承諾書必須以**正本**提交。若候選人或選舉代理人以電郵或傳真遞交表格，他們可在親身領取選民資料時簽署承諾書。他們須在鄉郊補選後兩星期內把正式選民登記冊的摘錄的硬複本及／或軟複本，以及從上述複本複製的選民個人資料妥善銷毀；以及於上述限期前把「確認已妥善銷毀選民資料的回條」填妥並交回有關的選舉主任。倘若候選人或選舉代理人未能於上述選舉後兩星期內向選舉主任交回有關回條，候選人或選舉代理人須將事件向香港個人資料私隱專員公署及有關執法部門（例如香港警務處）報告。

After submission of the nomination form, each candidate may request the hard copy and/or soft copy of an extract of the Final Register. Upon confirmation of the item(s) to be requested, the candidate or the election agent is required to return the completed reply slip of “Notice for Collection of Electors’ Information” together with the “Undertaking on the Use of Electors’ Information” by email, facsimile transmission or by post to the relevant Returning Officer. The **original** of the Undertaking must be submitted. If candidates or their election agents submit the forms by email or facsimile, they can sign the Undertaking when they collect the electors’ information in person. They should duly destroy the hard copy and/or soft copy of an extract of the Final Register and the electors’ personal data copied from the aforesaid copies within 2 weeks after the Rural By-election, and return the duly completed “Reply Slip on Confirmation of Destruction of the Elector’s Information” to the relevant Returning Officer before the above deadline. If the candidate or the election agent fail to return the relevant Reply Slip to the Returning Officer within 2 weeks after the above election, the candidate or election agent should report the incident to the Office of the Privacy Commissioner for Personal Data, Hong Kong and the relevant law enforcement agencies (e.g. the Hong Kong Police Force).
