## 填寫接受選舉捐贈預先申報書及聲明書說明

### Notes on Completion of Advance Return and Declaration of Election Donations

1. 在填寫此申報書及聲明書前，請閱讀《選舉（舞弊及非法行為）條例》（第 554 章）。  
Please read the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) before completing this return and declaration.
2. 選舉捐贈的形式包括金錢、貨品及服務。不論形式為何，所有已接受的選舉捐贈，均須在此申報書的相關部分填報。  
Election donations may take the form of money, goods or service. Regardless of the form they take, all election donations received must be accounted for under the relevant sections in this return.
3. 根據《選舉（舞弊及非法行為）條例》（第 554 章），“選舉捐贈”(election donation)就某項選舉的一名候選人而言，指以下任何捐贈—

  - (b) any goods given to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, and includes any goods given incidental to the provision of voluntary service;
  - (c) any service provided to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, but does not include voluntary service.

All personal data (including the address of the donor) in the return and declaration and all attachments will be covered before display. The personal data and other related information supplied in connection with this return and declaration may also be provided to other authorised departments, organisations or persons including but not limited to the law courts for election-related purposes.
