填寫撤銷授權招致選舉開支通知書說明

Notes on Completion of Notice of Revocation of Authorisation to Incur Election Expenses

- 1. 任何人士如未事前獲得候選人書面授權,皆不可招致選舉開支。
 No election expenses shall be incurred by any person unless he/she is so authorised beforehand by candidate in writing.
- 2. 有關招致選舉開支的授權書除非在選舉期間結束前被撤銷,否則該等授權書持續有效,直至選舉期間結束為止。 如要撤銷授權,作出該項授權的候選人須藉專人送遞、電子郵件、圖文傳真或(在投票日作出的撤銷委任通知 除外)郵遞方式,把撤銷授權招致選舉開支通知書的文本交付予選舉主任。

An authorisation to incur election expenses remains in force until the end of the election period unless it is revoked earlier. If an authorisation is to be revoked, candidate who made the authorisation must deliver a copy of the Notice of Revocation of Authorisation to Incur Election Expenses to the Returning Officer by hand, by electronic mail, by facsimile transmission or (except a notice of revocation of appointment made on polling day) by post.

3. 選舉主任在接獲撤銷授權招致選舉開支通知書後,方可視該項撤銷為有效。
The Returning Officer is to regard the revocation of authorisation to incur election expenses as being effective only when he/she receives the notice of revocation.

4. 任何年滿 18 歲並持有身分證明文件的人士均可擔任選舉開支代理人。"身分證明文件"(identity document)指

Any person holding an identity document and aged 18 years or over can be an election expense agent. "Identity document" (身分證明文件) means—

- (a) 身分證;或 an identity card; or
- (b) 向某人發出而可獲選舉主任接受為該人的身分證明的任何其他文件。 any other document issued to a person that is acceptable to the Returning Officer as proof of the person's identity.
- 5. 候選人應將通知書的副本交予被撤銷授權的人士。
 A copy of the notice should be provided by candidate to the person whose authorisation has been revoked.
- 6. 選舉主任會在切實可行範圍內盡快將送達予他/她的每份通知書文本的副本供公眾查閱。
 A copy of the notice will be made available for public inspection as soon as practicable after it is served on the Returning Officer.
- 7. 候選人必須在《選舉(舞弊及非法行為)條例》(第 554 章)第 37 條規定的限期屆滿之前,將填妥的「選舉開支及接受選舉捐贈之申報書及聲明書」(表格編號:HYK/C/11/2023)提交選舉主任。
 Candidate must lodge the duly completed "Return and Declaration of Election Expenses and Election Donations" (Form no.: HYK/C/11/2023) with the Returning Officer by the statutory deadline as required under section 37 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554).

- 9. 請注意下列有關在此通知書提供個人資料的說明-Please note the following with regard to the personal data supplied in connection with this notice-
 - (a) <u>資料用途</u>

就此通知書提供的個人資料及其他有關的資料,會供民政事務總署、選舉主任及有關的政府部門用於與選舉有關的用途。

Purpose of Collection

The personal data and other related information supplied in connection with this notice will be used by the Home Affairs Department, the Returning Officer and related government departments for election-related purposes.

(b) **資料轉**介

此通知書的副本將提供給公眾查閱直至選舉申報書的副本根據《選舉(舞弊及非法行為)條例》(第554章)第41條可供查閱的期間完結為止。在展示前,此通知書內所有身分證明文件類別及號碼將會被遮蓋。就此通知書提供的個人資料及其他有關資料亦可能會提供予其他獲授權的部門或人士,包括但不限於法院,用於與選舉有關的用途。

Transfer of Information

A copy of this notice will be made available for public inspection until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All identity document types and numbers provided in this notice will be covered before display. The personal data and other related information supplied in connection with this notice may also be provided to other authorised departments or persons, including but not limited to the law courts for election-related purposes.

Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in this notice in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
