Specified forms of nomination may be obtained free of charge during ordinary business hours on any day other than a general holiday from the New Territories District Offices, or from the Home Affairs Department, 30th Floor, Southorn Centre, 130 Hennessy Road, Wan Chai, Hong Kong.

If there is more than one validly nominated candidate for any of the above Villages, a poll for that Village will be held on 14 June 2015.
