- 2. 我明白候選人的監察投票代理人可以代表候選人進行一切候選人為與投票的進行相關的事宜所作的合法行動,包括在上述投票站觀察整個投票過程進行的情況,並將觀察所得的結果記錄下來。但不得做任何違法或足以干擾投票進行的事情。
  - I understand that the candidate's polling agents may do all the things on the candidate's behalf that the candidate can lawfully do for any purpose connected with the conduct of the poll, including observing all proceedings inside the above polling station and recording their observations. Nevertheless, they shall not do anything which is contrary to law or interfere with the conduct of the poll.
- 3. 我亦明白在投票當日,同一時間內只可以有上述其中一位監察投票代理人進入其獲委任的投票站。凡候選人或其選舉代理人正逗留在投票站內,則監察投票代理人不得同時逗留在該投票站內。而且,為了維持投票站內的秩序及確保投票過程得以順利進行,投票站主任可以規限在同一時間內進入投票站的候選人、選舉代理人及監察投票代理人的數目。
  - I also understand that only one of the above polling agents may be admitted at any one time to the polling station for which he/she has been appointed on the polling day. Whenever the candidate or his/her election agent is present within the polling station, his/her polling agents should not be present at the same time within that polling station. Moreover, the Presiding Officer may regulate the number of candidates, election agents and polling agents to be admitted to the polling station at any one time for the purpose of maintaining order in the polling station and ensuring that polling is conducted smoothly.
- 4. 我亦明白可於投票日前將由我簽署的書面通知送交有關鄉郊地區的選舉主任,或於投票當日親自送交監察投票代理人所負責的投票站主任,以撤銷此等監察投票代理人的委任。
  - I also understand that these appointments may be revoked by me before the polling day by delivering to the relevant Returning Officer for the relevant rural area, or on the polling day by delivering in person to the Presiding Officer for the polling station for which the polling agents are appointed, a notice in writing and signed by me to that effect.

# PART II POLLING AGENT'S/POLLING AGENTS' ACCEPTANCE AND UNDERSTANDING (To be completed by polling agent(s))

6. \*我/我們各人的個人資料已列於上述第 1 段,\*我現接受/我們現分別接受本通知書第一部分所述之委任。

\*I/Each of us, whose particulars are shown in paragraph 1 above, hereby accept(s) the appointment as stated in Part I of this notice.

7. \*我/我們每人均明白,\*我/我們須預先作出保密聲明,並於投票日向上述投票站的投票站主任報到時 出示該保密聲明及\*我/我們的香港身分證。

\*I/Each of us understand(s) that I/we must make a Declaration of Secrecy in advance and produce such Declaration of Secrecy and \*my/our Hong Kong Identity Card(s) when reporting to the Presiding Officer of the above polling station on the polling day.

- 8. \*我/我們每人均明白,在投票站內,\*我/我們<u>不得</u>-
  - \*I/Each of us understand(s) that inside the polling station, \*I/we **must not** –
  - (a) 從事拉票活動,或與任何選民談話或通信息,或干擾,或試圖影響他們; engage in the canvassing of votes, or speak to or communicate with or interfere with or attempt to influence any elector;
  - (b) 試圖探取或透露有關任何選民投票的任何資料; attempt to obtain or disclose any information concerning the vote of any elector;
  - (c) 拍影片、拍照、錄音或錄影; film, take photographs or make any audio or video recording;
  - (d) 展示、留下或派發任何選舉宣傳資料; exhibit or leave or distribute any campaign material;
  - (e) 展示、穿著或戴上可促使或阻礙一名或多於一名候選人在有關補選中當選的徽章、標誌、衣物或 頭飾;

display or wear any badge, emblem, clothing or head-dress which may promote or prejudice the election of a candidate or candidates at the by-election;

- (f) 展示、穿著或戴上直接提述有任何成員在有關補選中參選的團體的徽章、標誌、衣物或頭飾; display or wear any badge, emblem, clothing or head-dress which makes direct reference to a body any member of which is standing as a candidate in the by-election;
- (g) 使用流動電話、傳呼機或任何其他器材進行電子通訊;或 use a mobile telephone, paging machine or any other device for electronic communication; or

- 9. \*我/我們每人均明白,\*我/我們不得-
  - \*I/Each of us further understand(s) that \*I/we must not -
  - (a) 藉傳達關於選民在選民登記冊上的資料如選民身分證明文件號碼或姓名或,或藉其他方式,向他人 透露某人是否已申領選票或已於投票站投票;
    - divulge to any other person by communicating information such as the identity document number or name in the register of electors, or otherwise, as to whether a person has or has not applied for a ballot paper or voted at the polling station;
  - (b) 向他人傳達在投票站內獲取關於在該投票站的選民將會投票或已投票予哪位候選人的資料;或 communicate to any person any information obtained in the polling station as to the candidate for whom an elector in that polling station is about to vote or has voted; or

(c) 干擾或企圖干擾任何投票箱、未發出的選票、未用的選票、損壞的選票、重複的選票、經填劃的 選票及投票站員工使用之任何選民登記冊副本。

interfere with or attempt to interfere with any ballot boxes, unissued ballot papers, unused ballot papers, spoilt ballot papers, tendered ballot papers, marked ballot papers or any copy of the register of electors used by the polling staff at the polling station.

10. \*我/我們每人亦明白,倘若\*我/我們在投票站內或其鄰近範圍內或在禁止拉票區/禁止逗留區內行為不檢,或不服從選舉主任或投票站主任的任何合法指示,即屬違法,可被判罰款及監禁,並可能會被選舉主任或投票站主任命令立即離開該地方。倘若\*我/我們沒有離開,可能會被警務人員或獲選舉主任或投票站主任以書面授權的人員逐離該地方。如\*我/我們各人被逐離後,除非得到選舉主任或投票站主任的許可,否則在投票日不得再次進入有關地方。

\*I/Each of us also understand(s) that if \*I/we misconduct \*myself/ourselves at or in the vicinity of the polling station or within the no canvassing zone/no staying zone or fail to obey any lawful order of the Returning Officer or the Presiding Officer, \*I/we shall commit an offence punishable with a fine and imprisonment and may be ordered by such officer to leave the area immediately. \*My/Our failure to leave such area may result in \*my/our being removed by a police officer or a person authorised in writing by the Returning Officer or the Presiding Officer. If \*I am/we are so removed, \*I/we may not re-enter the relevant area on the polling day except with the permission of the Returning Officer or the Presiding Officer.

# Notes on Completion of Notice of Appointment of Polling Agents for a Polling Station Not Situated in a Prison

1. 除非候選人以指明表格明文另作示明,有關代理人須當作是為在預定日期進行的投票或(如適用的話)於遭 押後的該次投票而委任。

The agent is to be regarded as being appointed for the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.

2. 候選人或其選舉代理人可在該候選人獲提名的鄉郊地區內,就每個非位於監獄內的投票站**委任最多 2 名監察投票代理人**。凡年滿 18 歲的香港身分證持有人可被委任為監察投票代理人。候選人可委任同一人為多於一個投票站的監察投票代理人,但須在第一部分填寫有關的投票站名稱。如果某人被委任為所有該鄉郊地區內非位於監獄內的投票站的監察投票代理人,請在第一部分填寫"所有"。候選人或其選舉代理人不應委任任何選舉主任、助理選舉主任、或任何已受選舉主任委任協助進行投票或點票的人士(通常為政府公職人員)為其監察投票代理人。

A candidate or his election agent <u>may appoint a maximum of 2 polling agents</u> for each polling station not situated in a prison in respect of the Rural Area for which the candidate is nominated. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a polling agent. Candidate may appoint the same person as a polling agent for more than one polling station but the name of the relevant polling stations should be put in Part I. If a person is appointed as a polling agent for all the polling stations not situated in a prison in respect of the Rural Area, please put "ALL" in Part I. A candidate or his/her election agent should not appoint any Returning Officer, Assistant Returning Officer, or any person (usually a Government officer) already appointed by the Returning Officer to assist at the poll or the count as his/her polling agent.

- 3. (a) 就每名候選人而言,在候選人、其選舉代理人或其監察投票代理人中,同一時間內只限**一人**進入及停留在一個投票站內監察投票。因此,如候選人或他/她的選舉代理人正逗留在投票站內,則該候選人的監察投票代理人不得同時逗留在投票站內。
  - For each candidate, only **one** among the candidate, his/her election agent or his/her polling agent will be admitted to a polling station to observe the poll at any one time. Therefore, when a candidate or his/her election agent is present within a polling station, a polling agent of that candidate shall not be present at the same time in the polling station.
  - (b) 投票站主任可以規限可進入投票站的候選人、選舉代理人或監察投票代理人的數目。如可容納該等人 士的指定範圍已滿座,投票站主任可拒絕其他該等人士在該等時間進入投票站。
    - The admission into the polling station of a candidate, his/her election agent or polling agent is subject to the overriding power of the Presiding Officer to regulate the number of persons admitted to the polling station. If full capacity of the area inside the polling station designated for such persons has been reached, the Presiding Officer may refuse further admission.
  - (c) 進入投票站的指定範圍監察投票一般採用先到先得的方法。假若在同一時間內要求進入指定範圍的人數超額,將以抽籤決定進入的先後次序。
    - Admission to the designated area of the polling station to observe the poll will normally be on a first-come-first-served basis. If the number of persons seeking admission at the same time exceeds the capacity, then lots will be drawn to determine the priority of entry.
  - (d) 獲准進入指定範圍的人士,只可在指定範圍內逗留<u>一小時</u>;除非其後在指定範圍內的人數並未滿額, 亦無其他人士在輪候進入該範圍,否則一小時後他/她必須離開。每位進入投票站指定範圍的人士須 在投票站職員保管的簽到冊簽到並記錄進入時間。
    - A person will only be allowed to stay in the designated area for <u>ONE HOUR</u>, thereafter he/she must leave unless the designated area is not fully occupied and no other person is waiting to be admitted. Every person admitted to the polling station is required to sign in and enter the time of admission on the log book kept by the polling staff
  - (e) 當指定範圍所能容納的人數額滿時,輪候的每位人士會獲發一個號碼籌,以記錄指定範圍有空位時他 /她獲准入內的次序。當輪到持有某一號碼籌的人士進入該範圍時,投票站人員會在投票站入口讀出 該號碼。如該號碼持有人當時並不在場,則持有下一個號碼籌的人士會被獲准進入指定範圍。當缺席 的人士再次回到投票站外時,便須重新領取另一號碼籌輪候。
    - When the designated area is full, each person waiting to be admitted will be issued a number chit in sequence to record the order of his/her entry to the designated area when a vacant seat arises. When it is his/her turn, his/her number will be called outside the entrance to the polling station, but if he/she is not present, then admission will be granted to the one holding the next number chit. Such an absentee will have to obtain another number chit and join the queue afresh on his/her return.

(f) 如候選人或其代理人要求進入投票站但直至投票結束前的所有等候時段已滿,即沒有空缺的時段可以 分配給該候選人或其代理人。然而,如該候選人或其任何一位代理人均未曾於投票日進入該投票站觀 察投票,相關的投票站主任會盡量透過特別安排給予該候選人/代理人於投票結束前進入該投票站觀 察投票的機會。在這特別安排下,如果獲分配最後等候時段進入投票站的候選人或其任何一位代理 人,已曾於較早時獲分配時段於該投票站觀察投票,上述要求進入投票站的候選人或代理人將會取代 此人,獲分配該時段。

If a candidate or his/her agent seeks admission to a polling station but all the waiting slots are full until the close of poll, no vacant slot can be allocated to the candidate or his/her agent. However, if none of this candidate or his/her agent has earlier entered the polling station to observe the poll on the polling day, the Presiding Officer concerned will endeavour to give the candidate/agent an opportunity to enter the polling station to observe the poll before the close of poll under a special arrangement. Under this special arrangement, the person will replace the candidate or his/her agent who has been allocated the last waiting slot for admission to the polling station if this last candidate or any of his/her agents has already been given an earlier slot to observe the poll at that polling station.

- 4. 本通知書的第一部分應由候選人或選舉代理人填寫及簽署。第二部分應由各個監察投票代理人填寫及簽署。 Part I of the notice should be completed and signed by the candidate or the election agent. Part II should be completed and signed by each of the polling agents.
- 5. 委任監察投票代理人的委任通知書,須於投票日前的第7天或之前(即2016年11月20日或之前)藉專人送遞、郵遞、電子郵件或圖文傳真方式送交有關鄉郊地區的選舉主任,或於投票當日,由候選人或選舉代理人親自向監察投票代理人所負責的投票站的投票站主任遞交。逾期遞交的通知將不予接納。監察投票代理人的委任,在選舉主任或投票站主任(視何者適用而定)接獲委任通知書後始生效。

Notice of appointment of polling agents shall be delivered to the relevant Returning Officer for the relevant rural area by hand, by post, by electronic mail or by facsimile transmission at least 7 days before polling day (i.e. on or before 20 November 2016), or be given by the candidate or the election agent in person to the Presiding Officer for the polling station for which the polling agents are appointed on the polling day. Late submissions will not be accepted. The appointment of polling agents will not be effective until notice of appointment is received by the Returning Officer or the Presiding Officer, as may be appropriate.

## (a) 資料用途

就此通知書提供的個人及其他有關的資料,會供選舉管理委員會、民政事務總署、有關鄉郊地區的 選舉主任、有關投票站的投票站主任及有關政府部門用於與選舉有關的用途。

#### **Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, Home Affairs Department, the Returning Officer for the relevant rural area, the Presiding Officers for the relevant polling stations and government departments concerned for election-related purposes.

#### (b) <u>資料轉介</u>

在此通知書內的資料可能會提供予其他獲授權的部門/機構/人士,包括但不限於法院,用於與選舉有關的用途。

#### **Transfer of Information**

The information provided in this notice may be provided to other authorised departments/organizations/ persons including but not limited to the law courts for election-related purposes.

#### (c) 索閱個人資料

任何人有權根據《個人資料(私隱)條例》(第 486 章)的條文要求索閱及改正他/她所提供的個人資料。

## Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

# (d) 個人資料保障原則

請注意,候選人/選舉代理人在收集第三者的個人資料以填寫有關通知書時,須遵守《個人資料(私隱)條例》(第 486 章)附表 1 的保障資料原則,特別是第 4 原則,即採取所有切實可行的步驟,以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

### **Personal Data Protection Principle**

Candidate/election agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in completing the relevant notices, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorised or accidental access and processing.
