I declare that I am not disqualified from being nominated as a candidate at the above election, or from being elected as an Indigenous Inhabitant Representative for the above-mentioned Village by reason of the provisions of section 23 of the Rural Representative Election Ordinance (Cap.

576) or any other law. [see Note 17]

Notes on Completion of Nomination Form for the Rural By-election (Indigenous Inhabitant Representative)

以下說明只供參考。有關提名事宜的法例,請參閱《鄉郊代表選舉條例》(第 576 章)、《選舉程序 (鄉郊代表選舉)規例》(第 541 章,附屬法例 L)、《選舉 (舞弊及非法行為)條例》(第 554 章)及其他有關法例。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation.

- 1. 每份提名表格只能用以提名一位候選人。
 A separate nomination form must be used for each candidate.
- 2. 如候選人選擇公開其職業及任職公司/機構名稱的資料,他/她可在提名表格內申明。
 If a candidate so wishes, he/she can state his/her occupation and name of company/
 organisation on the nomination form.
- 3. 是否提供聯絡資料予傳媒使用屬自願性質。該等資料會提供予傳媒以便他們/她們直接聯絡有關候選人。
 - The supply of contact information for the media is optional. The information will be provided to the media to facilitate them to contact the candidate concerned directly.
- 4. 每份提名表格須由最少 5 位提名人親自簽署表示同意提名。所有提名人必須已登記為有關原居鄉村/共有代表鄉村的選民。為避免因有提名人不符合資格而令提名失效,提名表格可由多於 5 位提名人簽署。如超過 10 位提名人,必須使用提名表格第 3 頁的補充頁,而第 3 頁的每張補充頁均須填上由 "3(1)" 開始的順序頁碼。在遞交提名表格時,表格的每一頁(包括第 3 頁的所有補充頁)必須一併交予選舉主任。候選人應查證提名人的資格。倘若基於任何原因,某位提名人被發現不符合資格,他/她的提名將不予理會。候選人亦須提醒每位提名人應填寫在其身分證明文件(指提名人記錄在正式選民登記冊內的資料所依據的身分證明文件)上所顯示的姓名。

A nomination form must be <u>personally subscribed and signed by at least 5 subscribers. All the subscribers must be registered electors for the Indigenous Village/Composite Indigenous Village concerned.</u> To avoid the risk of invalidation of the nomination if any subscriber is ineligible, the nomination form may contain more than 5 subscribers. If there are more than 10 subscribers, the supplementary sheet of page 3 of the nomination form must be used. Each sheet of page 3 should be marked with a consecutive serial number starting with "3 (1)". All pages (including all sheets of page 3) of the form must be submitted to the Returning Officer in one complete set. A candidate should check the eligibility of the subscribers. If for any reason a subscriber is found to be ineligible, his/her subscription will be disregarded. A candidate should also remind each of the subscribers to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register).

- 5. 每一位鄉村的選民只可就該村的選舉,在指明數目的提名表格上以提名人身分簽署。指明數目的提名表格是指相等於該村在該選舉中須選出的原居民代表數目的提名表格。 An elector for a Village is entitled to subscribe the specified number of nomination forms only. The specified number of nomination forms means the number of nomination forms that is equivalent to the number of Indigenous Inhabitant Representative(s) to be returned for the Village at the election.
- 6. 請以<u>中文及英文提供候選人的姓名及主要住址,以便在政府憲報上刊登提名公告。有關填</u> 寫中文姓名及主要住址的注意事項,可參閱附錄。候選人必須填寫在其身分證明文件 (指

候選人記錄在有關鄉村正式選民登記冊內的資料所依據的身分證明文件,通常是其香港身分證)上所顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡體字寫法。未能遵守這項規定會延誤檢查身分證明文件工作及/或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示的姓名有所不同,該候選人可在別名一欄中加上該姓名。提名公告上顯示的候選人姓名(包括別名)會印在選票上。根據《選舉程序(鄉郊代表選舉)規例》(第541章,附屬法例 L)第12(1)及(2)條,選舉主任必須將一份關於某人是否獲有效提名的決定的通知,送交該人及有關鄉郊地區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。

For publication of the Notice of Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register for the Village concerned, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name on his/her identity document in Traditional Chinese or Simplified Chinese. Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name (including alias) of the candidate as shown in the Notice of Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the principal residential address(es) of the person(s)/candidate(s) concerned as given on the nomination forms.

A nomination form should be handed in by the candidate <u>in person</u> (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from <u>20 October 2016 to 2 November</u> <u>2016</u> (both days inclusive) during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday.

 - A prospective candidate is strongly advised to <u>submit his/her nomination form as early as practicable</u> so that any mistakes found in his/her nomination form can be rectified <u>before the close of nominations</u>.

 The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.

提出質疑外,不可循任何法律程序提出質疑。

Generally, unless and until the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he/she may hence carry out activities to promote his/her election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

A nomination form will not be valid unless it contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L). The Returning Officer may request such other information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.

A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election/ Kaifong Representative election in this Rural By-election. When a candidate hands in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any, or else his/her new nomination will be held to be invalid.

17. 根據《鄉郊代表選舉條例》(第 576 章)第 14、15、16、22 及 23 條,有關登記為選民的 資格、喪失登記為選民的資格、選民喪失在選舉(包括補選)中投票的資格、獲提名為候 選人的資格及喪失獲提名為候選人或當選為鄉郊代表的資格的規定如下,以作參考— Eligibility for registration as an elector, disqualification for being registered as an elector, disqualifications from voting at an election (including a by-election), qualifications for and disqualifications from being nominated as a candidate or being elected as a Rural Representative are dealt with in sections 14, 15, 16, 22 and 23 of the Rural Representative Election Ordinance (Cap. 576) which are reproduced below for reference —

- (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (f) is a member of the armed forces of the People's Republic of China or any other country or territory.

- (3) A person is disqualified from being elected as a Rural Representative if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection ceases to be disqualified if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs.
