Under section 104A of the Public Health and Municipal Services Ordinance (Cap. 132), a person is prohibited from displaying or affixing a bill or poster on any private land or Government land unless a written permission is obtained from the owner or occupier thereof or the Authority.

## 說明

### Notes

- (1) 根據《鄉郊代表選舉活動指引》第四章及《選舉程序(鄉郊代表選舉)規例》(第541L章)第92條,候選人須在發布選舉廣告後的一個工作天內(即公眾假期及星期六以外的任何一天),把與選舉廣告有關的資料/文件,包括准許的電子文件,上載至中央平台或候選人平台或向選舉主任繳存其印本式文本,以供公眾查閱。  
In accordance with Chapter 4 of the “Guidelines on Election-related Activities in respect of the Rural Representative Election” and section 92 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), the candidate should, **within 1 working day** (i.e. any day other than a general holiday and Saturday) after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission, onto the Central Platform or Candidate’s Platform or deposit a hard copy with the Returning Officer for public inspection.
- (2) 候選人在上載此批准書至中央平台或候選人平台前,必須確定已將批准書內所有電話號碼遮蓋。  
Candidates must ensure all telephone numbers in the permission have been covered before posting this permission onto the Central Platform or Candidate’s Platform.
