On receiving each election donation, whether by way of money, goods or service, of more than \$1,000 in value, a candidate must issue to the donor a receipt which specifies the name and address of the donor (as supplied by the donor) and the particulars of the election donation.

The original of the receipt for election donations should be given to the donor, and a copy should be kept by the candidate for record.
