Notes on Completion of Notification of Corrected Information in Relation to Election Advertisements

- 根據《選舉程序(鄉郊代表選舉)規例》(第 541L 章)第 91 條, "發布"是指印刷、展示、 展覽、分發、張貼、公布或以任何其他方式使公眾獲知,並包括繼續發布。
 - According to section 91 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), "publish" means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.
- 2. "准許"是指私人土地的擁有人或佔用人或政府土地的主管當局根據《公眾衞生及市政條例》 (第 132 章)第 104A(1)條,就候選人在該土地展示或張貼招貼或海報而給予的書面准許。
 - "Permission" means the written permission of the owner or the occupier of any private land or the authority of any government land given pursuant to section 104A(1) of the Public Health and Municipal Services Ordinance (Cap.132) for a candidate to display or affix a bill or poster on such land.
- 3. "同意書"是指任何人或組織根據《選舉(舞弊及非法行為)條例》(第 554 章)第 27 條, 就候選人發布或授權發布收納了該人或組織的姓名、名稱或標識或跟該人或組織有關聯的姓 名、名稱或標識;或與該人或組織的姓名、名稱或標識或與跟該人或組織有關聯的姓名、名稱 或標識甚為相似的姓名、名稱或標識;或該人的圖像的選舉廣告,而給予的書面同意。
 - "Consent" means the consent in writing by any person or organisation pursuant to section 27 of the Election (Corrupt and Illegal Conduct) Ordinance (Cap. 554) for a candidate to publish or authorise the publication of an election advertisement that includes the name or logo of or associated with the person or organisation; or a name or logo that is substantially similar to the name or logo of or associated with the person or organisation; or a pictorial representation of the person.
- 4. 候選人必須確保遞交的選舉廣告詳情符合《選舉程序(鄉郊代表選舉)規例》(第 541L 章) 第 92 條及《鄉郊代表選舉活動指引》第四章的規定及要求。候選人必須<u>藉專人送遞或郵遞</u>向 有關的選舉主任呈交此修正通知書。
 - The candidate must ensure that the election advertisement particulars submitted comply with the rules and requirements as set out in section 92 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), and Chapter 4 of the "Guidelines on Election-related Activities in respect of the Rural Representative Election". The candidate must deliver this Notification of Correction to the relevant Returning Officer by hand or by post.

- 7. 所有修正通知書必須**最遲於選舉日後兩個工作天(即公眾假期及星期六以外的任何一天)內**(即 2017年12月12日或之前)**或在延遲或押後的選舉日之後的兩個工作天內(如適用)**向選舉主任 繳存。所提交的修正通知書,以及此修正通知書第1頁第1段所指的資料摘要,會一同被作為 依據,用以審查和核對候選人的「選舉開支及接受選舉捐贈之申報書及聲明書」(表格編號: HAD/C1/By-E)。

All Notification of Correction must be deposited with the Returning Officer not later than 2 working days (i.e. any day other than a general holiday and Saturday) after the polling day (i.e. on or before 12 December 2017) or not later than 2 working days after the postponed or adjourned polling day, where applicable. Any Notification of Correction so deposited will be used together with the Information Sheet mentioned in paragraph 1 of page 1 of this notification as one of the bases for examining and checking the "Return and Declaration of Election Expenses and Election Donations" (Form no.: HAD/C1/By-E) of the candidate.

(a) 資料用途

Purpose of Collection

The personal data and other related information supplied in connection with this Notification of Correction will be used by the Electoral Affairs Commission, the Home Affairs Department, the Returning Officer for the relevant rural area and government departments concerned for election-related purposes.

(b) 資料轉介

選舉主任收到有關的資料摘要、此修正通知書、准許或授權書、同意書或選舉廣告樣本後,會將副本供公眾查閱直至選舉申報書的文本根據《選舉(舞弊及非法行為)條例》(第554章)第41條可供查閱的期間結束為止。在展示前,文件內所有身分證明文件號碼及電話號碼將會被遮蓋。就此修正通知書提供的個人及其他有關的資料亦可能會提供予其他獲授權的部門/機構/人士,包括但不限於法院,用於與選舉有關的用途。

Transfer of Information

A copy of the relevant Information Sheet, this Notification of Correction, permission or authorisation, consent or election advertisement sample will be made available by the Returning Officer who has received them for public inspection until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All identity document numbers and telephone numbers in the documents will be covered before display. The personal data and other related information supplied in connection with this Notification of Correction may also be provided to other authorised departments/organisations/persons including but not limited to the law courts for election-related purposes.

Access to Personal Data
