- (b) 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。 any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.
- 5. 根據《鄉郊代表選舉活動指引》第四章及《選舉程序(鄉郊代表選舉)規例》(第 541L 章)第 92 條,候選人須在發布選舉廣告後的一個工作天(即公眾假期及星期六以外的任何一天)內,把與選舉廣告有關的資料/文件,包括准許或同意書的電子文件,上載至中央平台或候選人平台或向選舉主任繳存其印本式文本,以供公眾查閱。

In accordance with Chapter 4 of the "Guidelines on Election-related Activities in respect of the Rural Representative Election" and section 92 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), the candidate must, within 1 working day (i.e. any day other than a general holiday and Saturday) after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate's Platform or deposit a hard copy with the Returning Officer for public inspection.

(a) 資料用途

Purpose of Collection

The personal data and other related information supplied in connection with this notification will be used by the Electoral Affairs Commission, the Home Affairs Department, the Returning Officer for the relevant rural area and government departments concerned for election-related purposes.

(b) 資料轉介

Transfer of Information

This notification will be made available for public inspection until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All telephone numbers in the notification will be covered before display. The personal data and other related information supplied in connection with this notification may also be provided to other authorised departments/organisations/persons including but not limited to the law courts for election-related purposes.

(c) 索閱個人資料

Access to Personal Data
