The Notes below are for reference only. L), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation.

A nomination form must be **personally subscribed and signed by at least 5 subscribers. All the subscribers must be registered electors for the Existing Village concerned.** To avoid the risk of invalidation of the nomination if any subscriber is ineligible, the nomination form may contain more than 5 subscribers. If there are more than 10 subscribers, the supplementary sheet of page 3 of the nomination form must be used. Each sheet of page 3 should be marked with a consecutive serial number starting with “3(1)”. All pages (including all sheets of page 3) of the form must be submitted to the Returning Officer in one complete set. A candidate should check the eligibility of the subscribers. If for any reason a subscriber is found to be ineligible, his/her subscription will be disregarded. A candidate should also remind each of the subscribers to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register).

An elector for an Existing Village is entitled to subscribe ONE nomination form only.

6. 請以中文及英文提供候選人的姓名及主要住址，以便在政府憲報上刊登提名公告。有關填寫中文姓名及主要住址的注意事項，可參閱附錄。候選人必須填寫在其身分證明文件(指候選人記錄在有關鄉村正式選民登記冊內的資料所依據的身分證明文件，通常是其香港身分證)上所顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡體字寫法。未能遵守這項規定會延誤檢查身分證明文件工作及/或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示的姓名有所不同，該候選人可在別名一欄中加上該姓名。提名公告上顯示的候選人姓名(包括別名)會印在選票上。根據《選舉程序(鄉郊代表選舉)規例》(第541章，附屬法例L)第12(1)及(2)條，選舉主任必須將一份關於某人是否獲有效提名的決定的通知，送交該人及有關鄉郊地區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。

For publication of the Notice of Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register for the Village concerned, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name on his/her identity document in Traditional Chinese or Simplified Chinese. Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name (including alias) of the candidate as shown in the Notice of Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the principal residential address(es) of the person(s)/candidate(s) concerned as given on the nomination forms.

A nomination form should be handed in by the candidate **in person** (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from **2 November 2017 to 15 November 2017** (both days inclusive) during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday.

A prospective candidate is strongly advised to submit his/her nomination form as early as practicable so that any mistakes found in his/her nomination form can be rectified before the close of nominations.

9. 任何提名表格所載候選人姓名或其他重要資料如經更改，將可能不被選舉主任接納。

The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.

10. 一般而言，除非選舉主任決定提名表格無效，否則獲提名的候選人即作為正式獲提名論，並可展開選舉活動。選舉主任就提名是否有效所作的決定，將為最終決定，除以選舉呈請提出質疑外，不可循任何法律程序提出質疑。

Generally, unless and until the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he/she may hence carry out activities to promote

his/her election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

11. 提名表格必須按《鄉郊代表選舉條例》(第 576 章)及《選舉程序(鄉郊代表選舉)規例》(第 541 章, 附屬法例 L) 的規定列載所需的資料, 方才有效。在決定候選人是否合乎資格及其提名有效與否時, 選舉主任可要求候選人提供其認為需要的額外資料。

A nomination form will not be valid unless it contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L). The Returning Officer may request such other information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.

12. 候選人不得在是次鄉郊補選中在超過一個鄉郊地區接受提名; 亦不可同時參選原居民代表及居民代表的選舉。候選人遞交一份提名表格時, 必須已退出在所有其他鄉郊地區的選舉, 否則, 其新的提名將會當作無效。

A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election in this Rural By-election. When a candidate hands in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any, or else his/her new nomination will be held to be invalid.

13. 現任鄉郊代表並無資格在這次補選中被提名為候選人。

An incumbent Rural Representative is not eligible to be nominated as a candidate in the by-election.

14. 候選人如欲退出選舉可填寫一份「候選人退選通知書」的指明表格(HAD/C/5/By-E), 並最遲於提名期結束前送遞予有關的選舉主任。

If a candidate wishes to withdraw his/her candidature, he/she may do so by completing and delivering to the Returning Officer concerned a "Notice of Withdrawal of Candidature" in a specified form (HAD/C5/By-E) before the close of nominations.

15. 本提名表格第二部分必須於見證人在場下由候選人填寫及簽署。任何年滿 18 歲並持有有效身分證明文件的人士均可擔任見證人。見證人必須填寫及簽署本提名表格第三部分。根據《鄉郊代表選舉條例》(第 576 章)第 2(1)條, “身分證明文件”(identity document)指—

Part II of this nomination form should be completed and signed by a candidate in the presence of a witness who can be any person in possession of a valid identity document and aged 18 years or over. The witness is required to complete Part III of this form and sign thereunder. According to section 2(1) of the Rural Representative Election Ordinance (Cap. 576), “identity document” (身分證明文件) means –

Eligibility for registration as an elector, disqualification for being registered as an elector, disqualifications from voting at an election (including a by-election), qualifications for and disqualifications from being nominated as a candidate or being elected as a Rural Representative are dealt with in sections 14, 15, 16, 22 and 23 of the Rural Representative Election Ordinance (Cap. 576) which are reproduced below for reference —

已登記為某鄉郊地區的選民的人如有以下情況，即喪失在該地區的選舉中投票的資格 — (由2014年第5號第2條修訂)

- (a) 他已不再有資格如此登記；
- (b)-(d) (由2009年第7號第10條廢除)
- (e) 他根據《精神健康條例》(第136章)被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務；或
- (f) 他是中華人民共和國或任何其他國家或地區的武裝部隊的成員。

***When an elector is disqualified from voting at an election (section 14 of the Rural Representative Election Ordinance (Cap. 576))***

A person registered as an elector for a Rural Area is disqualified from voting at an election for the Rural Area if the person- (Amended 5 of 2014 s. 2)

- (a) has ceased to be eligible to be so registered;
- (b)-(d) (Repealed 7 of 2009 s. 10)
- (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (f) is a member of the armed forces of the People's Republic of China or any other country or territory.

**登記為選民的資格〔《鄉郊代表選舉條例》(第576章)第15條〕**

(4) 任何人除非符合以下條件，否則沒有資格登記為現有鄉村的選民—

- (a) 他是該村的居民；
- (b) 他在緊接申請登記當日之前的3年內一直是該村的居民；
- (c) 他是成年人，或將於他申請登記後的首個10月20日或之前成為成年人；及 (由2009年第12號第6條修訂)
- (d) 他是香港永久性居民。

***Who is eligible to be registered as an elector (section 15 of the Rural Representative Election Ordinance (Cap. 576))***

(4) A person is not eligible to be registered as an elector for an Existing Village unless the person-

- (a) is a resident of the Village;
- (b) has been a resident of the Village for the 3 years immediately before the date of application for registration;
- (c) is an adult, or will be an adult on or before 20 October next following the person's application for registration; and (Amended 12 of 2009 s. 6)
- (d) is a Hong Kong permanent resident.

**喪失登記為選民的資格的情況〔《鄉郊代表選舉條例》(第576章)第16條〕**

任何人如有以下情況，即喪失登記為鄉郊地區的選民的資格— (由2014年第5號第2條修訂)

- (a)-(c) (由2009年第7號第11條廢除)
- (d) 他根據《精神健康條例》(第136章)被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務；或
- (e) 他是中華人民共和國或任何其他國家或地區的武裝部隊的成員。

***When a person is disqualified from being registered as an elector (section 16 of the Rural Representative Election Ordinance (Cap. 576))***

A person is disqualified from being registered as an elector for a Rural Area if the person-

(Amended 5 of 2014 s. 2)

(a)-(c) (Repealed 7 of 2009 s. 11)

(d) is found under the Mental Health Ordinance (Cap 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or

(e) is a member of the armed forces of the People's Republic of China or any other country or territory.

***獲提名為候選人的資格〔《鄉郊代表選舉條例》(第576章)第22條〕***

(1) 符合以下條件的人方有資格在現有鄉村選舉中獲提名為候選人—

(a) 是該村的居民；

**(b) 在緊接提名之前的6年內一直是該村的居民；**

(c) 年滿21歲；

(d) 已登記並有資格登記為該村的選民；

(e) 沒有喪失在該選舉中投票的資格；及

(f) 沒有因第23條或任何其他法律喪失獲提名為該選舉的候選人或當選為該村的居民代表的資格。

(4) 任何人如已獲提名為某鄉郊地區的選舉的候選人，則沒有資格同時獲提名為另一鄉郊地區的選舉的候選人。(由2014年第5號第2條修訂)

***Who is eligible to be nominated as a candidate (section 22 of the Rural Representative Election Ordinance (Cap. 576))***

(1) A person is eligible to be nominated as a candidate at an election for an Existing Village only if the person-

(a) is a resident of the Village;

**(b) has been a resident of the Village for the 6 years immediately preceding the nomination;**

(c) has reached 21 years of age;

(d) is registered, and eligible to be registered, as an elector for the Village;

(e) is not disqualified from voting at the election; and

(f) is not disqualified from being nominated as a candidate at the election, or from being elected as a Resident Representative for the Village, by virtue of section 23 or any other law.

(4) A person is not eligible to be nominated as a candidate at an election for a Rural Area if the person is currently nominated as a candidate at an election for another Rural Area. (Amended 5 of 2014 s. 2)

***喪失獲提名為候選人及當選為鄉郊代表的資格的情況〔《鄉郊代表選舉條例》(第576章)第23條〕***

(1) 任何人如有以下情況，即喪失在選舉中獲提名為候選人的資格及當選為有關鄉郊地區的鄉郊代表的資格 — (由2014年第5號第2條修訂)

(a) 他是司法人員；

(b) 他已在香港或任何其他地方被判處死刑或監禁 (不論如何稱述)，但 —

(i) 未服該刑罰或主管當局用以替代該刑罰的其他懲罰；而亦

(ii) 未獲赦免<sup>1</sup>；

<sup>1</sup> 原訟法庭於2012年6月21日就黃軒璋訴律政司司長(高院憲法及行政法訴訟2012年第51號)及梁國雄訴律政司司長(高院憲法及行政法訴訟2012年第54號)給予書面判詞，裁定《立法會條例》第39(1)(b)條(與《鄉郊代表選舉條例》第23(1)(b)條相若)違憲。政府當局已於2012年7月12日宣布決定不會就有關判決提出上訴。日後的鄉郊代表選舉會按當時生效的法例進行。任何人士如欲在鄉郊代表選舉獲提名為候選人，並對他/她的提名資格有疑問，他/她可徵詢獨立法律意見。

- (c) 他已被裁定犯叛逆罪；
- (d) 在獲提名當日或選舉當日，他正因服刑而受監禁；
- (e) 在不局限 (b) 段的原則下，他被裁定或曾被裁定犯以下罪行，而該選舉於或將於他被定罪日期後的 5 年內舉行 –
  - (i) 任何罪行（不論是在香港或是在任何其他地方被定罪），並就該罪行被判處為期超逾 3 個月而又不得選擇以罰款代替的監禁（不論是否獲得緩刑）；
  - (ii) 作出舞弊或非法行為；
  - (iii) 《防止賄賂條例》(第 201 章) 第 II 部所訂的罪行；或
  - (iv) 選管會規例所訂明的任何罪行；
- (f) 他因本條例或任何其他法律的施行而沒有資格在該選舉中擔任候選人或當選為該地區的鄉郊代表；（由 2014 年第 5 號第 2 條修訂）
- (g) 他是香港以外地方的政府的代表或該政府的受薪政府人員；
- (h) 他是香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；或
- (i) 他是未獲解除破產的人，或於過去 5 年內在沒有向債權人全數償還債務的情況下獲解除破產或與其債權人達成《破產條例》(第 6 章)所指的自願安排的人。
  - (2) 任何人如根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失在選舉中獲提名為候選人的資格；但根據本款喪失資格的人如在其後根據該條例獲裁斷為已有能力處理和管理其財產及事務，即有資格在選舉中獲提名為候選人。
  - (3) 任何人如根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失當選為鄉郊代表的資格；但根據本款喪失資格的人如在其後根據該條例獲裁斷為已有能力處理和管理其財產及事務，即有資格當選為鄉郊代表。（由 2014 年第 5 號第 2 條修訂）
  - (4) 任何人如在有關現有鄉村的選舉的候選人提名期結束後任何時間，不再是該村的居民，即喪失當選為該村的居民代表的資格。

***When a person is disqualified from being nominated as a candidate and from being elected as a Rural Representative (section 23 of the Rural Representative Election Ordinance (Cap. 576))***

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Rural Representative for a Rural Area, if the person- (Amended 5 of 2014 s. 2)
  - (a) is a judicial officer;
  - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not-
    - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
    - (ii) received a free pardon<sup>1</sup>;
  - (c) has been convicted of treason;
  - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment;
  - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted-
    - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine;
    - (ii) of having engaged in corrupt or illegal conduct;

<sup>1</sup> The Court of First Instance delivered written judgment on 21 June 2012 on Wong Hin Wai v Secretary for Justice (HCAL 51/2012) and Leung Kwok Hung v Secretary for Justice (HCAL 54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (which is similar to section 23(1)(b) of Rural Representative Election Ordinance) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future Rural Representative elections will be organised in accordance with the prevalent electoral laws. Any person who would like to be nominated as a candidate for a Rural Representative election and is doubtful about his/her eligibility for nomination may seek independent legal advice.

- (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201);  
or
  - (iv) of any offence prescribed by the EAC Regulations;
  - (f) is ineligible to be a candidate at the election, or to be elected as a Rural Representative for the Rural Area, because of the operation of this Ordinance or any other law; (Amended 5 of 2014 s. 2)
  - (g) is a representative or a salaried functionary of the government of a place outside Hong Kong;
  - (h) is a member of any national, regional or municipal legislature, assembly or council of a place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national level or local level; or
  - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (2) A person is disqualified from being nominated as a candidate at an election if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection is eligible to be nominated as a candidate at an election if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs.
- (3) A person is disqualified from being elected as a Rural Representative if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection ceases to be disqualified if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs. (Amended 5 of 2014 s. 2)
- (4) A person is disqualified from being elected as a Resident Representative for an Existing Village if, at any time after the close of nominations of candidates for election for the Village, the person ceases to be a resident of the Village.
