I have sufficient knowledge about the arrangements made by the Applicant Organisation in relation to the proposed exit poll. I am also responsible for the supervision, on behalf of the Applicant Organisation, of the conduct of the exit poll, including the conduct of those persons who will be assigned with any duty in the exit poll and those who will be deployed for the conduct of the exit poll as listed in Attachment I.

I am not contesting in the Rural Area covered by the exit poll. * The bodies to which I belong / The Applicant Organisation have / has no member contesting in the Rural Area covered by the exit poll. I, * the bodies to which I belong / the Applicant Organisation and members thereof have not publicly expressed support for any candidate contesting in the Rural Area covered by the exit poll.

If there is a change of circumstances after submission of the Application Form such that any person listed in Attachment I falls into one of the categories mentioned above, * I / The Applicant Organisation and I will amend the list under Attachment I to ensure that no person belonging to the three categories above is deployed to assume any duty in the exit poll or to conduct the exit poll on the polling day, and will submit the updated list to the HAD as soon as possible before the polling day.

- * I / The Applicant Organisation and I will not announce or disclose the results of the exit poll or make specific remarks or predictions on the performance of any candidate before the close of poll.
9. * 本人／本人及申請機構不會在投票結束前，直接或間接向任何在票站調查涵蓋的鄉郊地區參選的候選人、任何已公開表明支持在票站調查涵蓋的鄉郊地區參選的任何候選人的人士或機構、或任何已有成員在票站調查涵蓋的鄉郊地區參選的機構，發放票站調查的結果或就任何候選人的表現發表具體評論或預測。
- * I / The Applicant Organisation and I will not release, directly or indirectly, the results of the exit poll or make specific remarks or predictions on the performance of any candidate, to any candidate contesting in the Rural Area covered by the exit poll, any person who or organisation which has publicly expressed support for any candidate contesting in the Rural Area covered by the exit poll, or any organisation with member(s) contesting in the Rural Area covered by the exit poll, before the close of poll.
10. * 本人／本人及申請機構只會為申請表第三部分所列出的目的進行票站調查，並會遵守由選舉管理委員會（“選管會”）發布的《鄉郊代表選舉活動指引》（“《指引》”）及相關補充資料（如有的話）內關於進行票站調查的規定，特別是第 11 章，包括（但不限於）附件一列明的人士需要遵守的下列規定 –
- 在進行票站調查時，必須顯著地展示由民政事務總署發出的身分識別名牌／標記；
 - 尊重選民不願意受到打擾的權利和意欲；
 - 在進行票站調查前，使用民政事務總署提供的標準對話稿，告知接受調查的選民，他們參與票站調查純屬自願；
 - 在調查開始時，須向選民表明進行票站調查的人士或機構的名稱及調查並非由政府委託進行；
 - 不可收集或保留有關選民身分的任何個人資料（例如姓名及香港身分證號碼）；
 - 不得在指定為禁止逗留區的範圍內逗留、遊蕩或趨前與選民交談；及
 - 不得在禁止拉票區範圍內向選民拉票或作出任何會令人懷疑是向選民拉票的行為（請參閱《指引》第 10 章）。

* I / The Applicant Organisation and I will conduct the exit poll only for the purpose(s) stated in PART III of the Application Form, and in full compliance with the rules governing the conduct of exit polls in the Guidelines on Election-related Activities in respect of the Rural Representative Election (“the Guidelines”) and relevant supplementary information (if any) issued by the Electoral Affairs Commission (“EAC”), especially Chapter 11, including (but not limited to) the following requirements to be observed by those persons listed in Attachment I -

- display prominently the identification device issued by the HAD when conducting the exit poll;
- respect the electors’ right and wish not to be disturbed;
- prior to conduct of exit poll, use the standard script provided by the HAD to inform the electors being interviewed that their participation in the exit poll is entirely voluntary;
- at the start of the interview, make known to the electors the name of the person or organisation conducting the exit poll and that the exit poll is not commissioned by the Government;
- not to collect or retain any personal data (such as name and Hong Kong Identity Card number) relating to the identity of the electors;
- not to stay, loiter or accost electors in the areas designated as the No Staying Zone; and
- not to canvass electors in the No Canvassing Zone or carry out any activities that will give rise to any suspicion that they are canvassing electors inside the No Canvassing Zone (please refer to Chapter 10 of the Guidelines).

11. 本人明白，所有被委派在是次票站調查中擔任任何職務的人士，以及附件一列明的人士，均須遵守《指引》內關於進行票站調查的規定以及本部分第 4 至 10 及 13 段所述事項。因此，* 本人／本人及申請機構會確保所有上述人士均接受一切必需的訓練及督導，以使他們知悉和嚴格遵守上述規定和事項。

I understand that all persons deployed to assume any duty in the exit poll and all persons listed in Attachment I shall observe the rules in the Guidelines governing the conduct of exit polls and the matters stated in paragraphs 4 to 10 and 13 of this PART. Therefore, * I / The Applicant Organisation and I will ensure that all persons mentioned above are given all necessary training and supervision, so that they know and strictly comply with the above rules and matters.

I understand that, if * I or any person conducting the exit poll / I, the Applicant Organisation or any person conducting the exit poll fail(s) to comply with the rules in the Guidelines governing the conduct of exit polls or the matters stated in paragraphs 4 to 10 of this PART, the HAD may revoke the approval to conduct an exit poll on the polling day or during the polling hours forthwith without prior warning. The EAC may also make a reprimand or censure in a public statement which will include the name of

the person or organisation who / which fails to comply with this declaration or the Guidelines and may take legal action against such person or organisation.

Guidance Notes on Completion of Application Form

1. 在填寫此申請表前，請細心閱讀《鄉郊代表選舉活動指引》及相關補充資料（如有的話）。
Please read carefully the Guidelines on Election-related Activities in respect of the Rural Representative Election and relevant supplementary information (if any) before completing this Application Form.
2. 請用中文或英文填寫此申請表。
Please complete this Application Form either in Chinese or in English.
3. 有意申請進行票站調查的機構，在決定由誰人作出法定聲明時，應考慮該人是否符合申請表第一部分第1段所述的要求。
Any **organisation** which intends to apply to conduct an exit poll, when deciding who is to make the statutory declaration, should consider whether such person satisfies the requirements stated in paragraph 1 of PART I of the Application Form.
4. 已填妥的申請表正本必須不遲於投票日十天前以親身或郵寄方式呈交民政事務總署（地址：香港灣仔軒尼詩道130號修頓中心30樓，第一科第2小組收）。如申請人／申請機構未能在投票日十天前提供本申請表所需的準確資料，其票站調查之申請可能不獲處理。
The **original** of the completed Application Form must be submitted in person or by post to the Home Affairs Department (“HAD”) (Address: 30th Floor, Southorn Centre, 130 Hennessy Road, Wan Chai, Hong Kong (Attention: Team 2, Division I)) not later than 10 days before the polling day. If applicants / applicant organisations fail to provide accurate data as requested in this Application Form 10 days before the polling day, their applications to conduct an exit poll may not be processed.

If applicants / applicant organisations do not receive any reply from the HAD 7 days after submission of their application, please call 2152 1521 to check the progress of their application.
6. 請保留一份申請表的副本作未來參考之用。
Please keep a copy of the Application Form for future reference.
7. 根據《鄉郊代表選舉條例》（第576章）第2條，“身分證明文件”指 –
 - (a) 身分證，即根據《人事登記條例》（第177章）向某人發出的身分證；或根據該條例向某人發出並證明該人獲豁免而無需根據該條例登記的任何其他文件；或
 - (b) 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。According to section 2 of the Rural Representative Election Ordinance (Cap. 576), “identity document” means -
 - (a) an identity card, i.e. an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or any other document issued to a person under that Ordinance certifying that the person is exempt from being required to register under that Ordinance; or
 - (b) any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.

(a) 資料用途

就此申請表提供的個人及其他有關的資料，會供選舉管理委員會及民政事務總署用作與選舉有關的用途。獲准進行票站調查的機構或人士名單，連同其聯絡電話號碼，會於投票日前發放供公眾及候選人參閱。該名單並會張貼於各相關投票站。所有身分證明文件號碼及聲明人的住址在發放前會被遮蓋。

(b) 資料轉介

就此申請表提供的個人及其他有關的資料可能會提供予其他獲授權的部門或人士，包括但不限於法院，用於與選舉有關的用途。

(c) 索閱個人資料

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他／她所提供的其個人資料。

(d) 個人資料保障原則

請注意，申請人在收集第三者的個人資料以填寫此申請表時，須遵守《個人資料（私隱）條例》（第 486 章）附表一的保障資料原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保資料受到保障而不受未獲准許的或意外的查閱、處理和使用。

(e) 查詢

有關透過此申請表收集的個人資料的查詢，包括索閱及改正個人資料，應向民政事務總署〔地址：香港灣仔軒尼詩道130號修頓中心30樓〕提出。

Please note the following with regard to the personal data supplied in connection with this Application Form –

(a) Purpose of Collection

The personal data and other related information supplied in connection with this Application Form will be used by the Electoral Affairs Commission and the HAD for election-related purposes. A list of organisations or persons allowed to conduct exit polls, together with their contact telephone numbers will be released prior to the polling day for reference by the public and candidates. Such a list will also be displayed at the respective polling stations. All the identity document numbers and the declarants' addresses will be covered up before the lists are displayed.

(b) Transfer of Information

The personal data and other related information supplied in connection with this Application Form may be provided to other authorised departments or persons, including but not limited to the courts for election-related purposes.

(c) Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) Personal Data Protection Principles

Please note that applicants must observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this Application Form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that the personal data are protected against unauthorised or

accidental access, processing and use.

(e) Enquiry

Enquiries concerning the personal data collected by means of this Application Form, including requests for access to and corrections of personal data, should be addressed to the Home Affairs Department (Address: 30th Floor, Southorn Centre, 130 Hennessy Road, Wan Chai, Hong Kong).
