## 填寫鄉郊補選(原居民代表)提名表格說明

### Notes on Completion of Nomination Form for the Rural By-election (Indigenous Inhabitant Representative)

以下說明只供參考。有關提名事宜的法例，請參閱《鄉郊代表選舉條例》(第 576 章)、《選舉程序 (鄉郊代表選舉) 規例》(第 541 章，附屬法例 L)、《選舉 (舞弊及非法行為) 條例》(第 554 章) 及其他有關法例。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation.

1. 每份提名表格只能用以提名一位候選人。  
A separate nomination form must be used for each candidate.
2. 如候選人選擇公開其職業及任職公司/機構名稱的資料，他/她可在提名表格內申明。  
If a candidate so wishes, he/she can state his/her occupation and name of company/organisation on the nomination form.
3. 是否提供聯絡資料予傳媒使用屬自願性質。該等資料會提供予傳媒以便他們/她們直接聯絡有關候選人。  
The supply of contact information for the media is optional. The information will be provided to the media to facilitate them to contact the candidate concerned directly.
4. 每份提名表格須由最少 5 位提名人親自簽署表示同意提名。所有提名人必須已登記為有關原居鄉村/共有代表鄉村的選民。為避免因有提名人不符合資格而令提名失效，提名表格可由多於 5 位提名人簽署。如超過 10 位提名人，必須使用提名表格第 3 頁的補充頁，而第 3 頁的每張補充頁均須填上由“3(1)”開始的順序頁碼。在遞交提名表格時，表格的每一頁(包括第 3 頁的所有補充頁)必須一併交予選舉主任。候選人應查證提名人的資格。倘若基於任何原因，某位提名人被發現不符合資格，他/她的提名將不予理會。候選人亦須提醒每位提名人應填寫在其身分證明文件(指提名人記錄在正式選民登記冊內的資料所依據的身分證明文件)上所顯示的姓名。  
A nomination form must be **personally subscribed and signed by at least 5 subscribers. All the subscribers must be registered electors for the Indigenous Village/Composite Indigenous Village concerned.** To avoid the risk of invalidation of the nomination if any subscriber is ineligible, the nomination form may contain more than 5 subscribers. If there are more than 10 subscribers, the supplementary sheet of page 3 of the nomination form must be used. Each sheet of page 3 should be marked with a consecutive serial number starting with “3 (1)”. All pages (including all sheets of page 3) of the form must be submitted to the Returning Officer in one complete set. A candidate should check the eligibility of the subscribers. If for any reason a subscriber is found to be ineligible, his/her subscription will be disregarded. A candidate should also remind each of the subscribers to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register).
5. 每一位鄉村的選民只可就該村的選舉，在指明數目的提名表格上以提名人身分簽署。指明數目的提名表格是指相等於該村在該選舉中須選出的原居民代表數目的提名表格。  
An elector for a Village is entitled to subscribe the specified number of nomination forms only. The specified number of nomination forms means the number of nomination forms that is equivalent to the number of Indigenous Inhabitant Representative(s) to be returned for the Village at the election.
6. 請以中文及英文提供候選人的姓名及主要住址，以便在政府憲報上刊登提名公告。有關填寫中文姓名及主要住址的注意事項，可參閱附錄。候選人必須填寫在其身分證明文件(指

候選人記錄在有關鄉村正式選民登記冊內的資料所依據的身分證明文件，通常是其香港身分證)上所顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證文件上所顯示的繁體字或簡體字寫法。未能遵守這項規定會延誤檢查身分證文件工作及/或令候選人須返回選舉主任辦事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證文件上所顯示的姓名有所不同，該候選人可在別名一欄中加上該姓名。提名公告上顯示的候選人姓名(包括別名)會印在選票上。根據《選舉程序(鄉郊代表選舉)規例》(第541章，附屬法例L)第12(1)及(2)條，選舉主任必須將一份關於某人是否獲有效提名的決定的通知，送交該人及有關鄉郊地區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。

For publication of the Notice of Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register for the Village concerned, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name on his/her identity document in Traditional Chinese or Simplified Chinese. Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name (including alias) of the candidate as shown in the Notice of Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the principal residential address(es) of the person(s)/candidate(s) concerned as given on the nomination forms.

7. 候選人只有在沒有香港身分證的情況下，才可填寫其他身分證文件的類別及號碼。  
The candidate can provide his/her identity document type and number only if he/she does not have a Hong Kong Identity Card.
8. 提名表格必須在提名期：**2018年8月30日至2018年9月12日內**（首尾兩天包括內），除公眾假期外的任何日子，於辦公時間內（星期一至星期五：上午九時正至下午五時正；星期六：上午九時正至正午十二時正）由候選人**親自**送交給有關的選舉主任（已向選舉主任申請並獲批准以其他方式遞交者除外）。  
A nomination form should be handed in by the candidate **in person** (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from **30 August 2018 to 12 September 2018** (both days inclusive) during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday.
9. 準候選人應盡早遞交提名表格，以便於提名期結束前，將提名表格上可能發現的錯誤更正。  
A prospective candidate is strongly advised to **submit his/her nomination form as early as practicable** so that any mistakes found in his/her nomination form can be rectified **before the close of nominations**.
10. 任何提名表格所載候選人姓名或其他重要資料如經更改，將可能不被選舉主任接納。  
The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.
11. 一般而言，除非選舉主任決定提名表格無效，否則獲提名的候選人即作為正式獲提名論，並可展開選舉活動。選舉主任就提名是否有效所作的決定，將為最終決定，除以選舉呈請

提出質疑外，不可循任何法律程序提出質疑。

Generally, unless and until the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he/she may hence carry out activities to promote his/her election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

12. 提名表格必須按《鄉郊代表選舉條例》（第 576 章）及《選舉程序（鄉郊代表選舉）規例》（第 541 章，附屬法例 L）的規定列載所需的資料，方才有效。在決定候選人是否合乎資格及其提名有效與否時，選舉主任可要求候選人提供其認為需要的額外資料。  
A nomination form will not be valid unless it contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L). The Returning Officer may request such other information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.
13. 候選人不得在是次鄉郊補選中在超過一個鄉郊地區接受提名；亦不可同時參選原居民代表及居民代表/街坊代表的選舉。候選人遞交一份提名表格時，必須已退出在所有其他鄉郊地區的選舉，否則，其新的提名將會當作無效。  
A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election/ Kaifong Representative election in this Rural By-election. When a candidate hands in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any, or else his/her new nomination will be held to be invalid.
14. 現任鄉郊代表並無資格在這次補選中被提名為候選人。  
An incumbent Rural Representative is not eligible to be nominated as a candidate in the by-election.
15. 候選人如欲退出選舉，可填寫一份「候選人退選通知書」的指明表格（HAD/C5/By-E），並最遲於提名期結束前送遞予有關的選舉主任。  
If a candidate wishes to withdraw his/her candidature, he/she may do so by completing and delivering to the Returning Officer concerned a “Notice of Withdrawal of Candidature” in a specified form (HAD/C5/By-E) before the close of nominations.
16. 本提名表格第二部分必須於見證人在場下由候選人填寫及簽署。任何年滿 18 歲並持有有效身分證明文件的人士均可擔任見證人。見證人必須填寫及簽署本提名表格第三部分。根據《鄉郊代表選舉條例》（第 576 章）第 2(1)條，“身分證明文件”（identity document）指 —  
Part II of this nomination form should be completed and signed by a candidate in the presence of a witness who can be any person in possession of a valid identity document and aged 18 years or over. A person registered as an elector for a Rural Area is disqualified from voting at an election for the Rural Area if the person- (Amended 5 of 2014 s. 2)

- (a) has ceased to be eligible to be so registered;
- (b)-(d) (Repealed 7 of 2009 s. 10)
- (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (f) is a member of the armed forces of the People's Republic of China or any other country or territory.

- (b) is an adult, or will be an adult on or before 20 October next following the person's application for registration; (Amended 12 of 2009 s. 6)
- (c) at the time of applying to be registered, satisfies the Electoral Registration Officer that the person-
  - (i) holds an identity document; or
  - (ii) has-

- (A) applied for a new identity card; or
- (B) requested the alteration of the identity card or the issue of a new identity card, in replacement of the identity card previously issued to the person; and
- (d) at the time of applying to be registered-
  - (i) if the identity document held by, or previously issued to, the person is an identity card, informs the Electoral Registration Officer of the identifying number of the identity card;
  - (ii) if the identity document held by the person is not an identity card, provides the Electoral Registration Officer a copy of the identity document.

- (a)-(c) (Repealed 7 of 2009 s. 11)
- (d) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (e) is a member of the armed forces of the People's Republic of China or any other country or territory.

- (b) has reached 21 years of age;
- (c) is registered, and eligible to be registered, as an elector for the Village;
- (d) is not disqualified from voting at the election;
- (e) is not disqualified from being nominated as a candidate at the election, or from being elected as an Indigenous Inhabitant Representative for the Village, by virtue of section 23 or any other law;
- (f) is a Hong Kong permanent resident; and
- (g) **ordinarily resides in Hong Kong.**

(4) A person is not eligible to be nominated as a candidate at an election for a Rural Area if the person is currently nominated as a candidate at an election for another Rural Area. (Amended 5 of 2014 s. 2)

***When a person is disqualified from being nominated as a candidate and from being elected as a Rural Representative (section 23 of the Rural Representative Election Ordinance (Cap. 576))***

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Rural Representative for a Rural Area, if the person- (Amended 5 of 2014 s. 2)
- (a) is a judicial officer;
  - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not-
    - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or

  - (h) is a member of any national, regional or municipal legislature, assembly or council of a place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national level or local level; or
  - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (2) A person is disqualified from being nominated as a candidate at an election if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection is eligible to be nominated as a candidate at an election if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs.
- (3) A person is disqualified from being elected as a Rural Representative if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection ceases to be disqualified if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs. (Amended 5 of 2014 s. 2)

<sup>1</sup> The Court of First Instance delivered written judgment on 21 June 2012 on Wong Hin Wai v Secretary for Justice (HCAL 51/2012) and Leung Kwok Hung v Secretary for Justice (HCAL 54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (which is similar to section 23(1)(b) of Rural Representative Election Ordinance) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future Rural Representative elections will be organised in accordance with the prevalent electoral laws.
