- at the start of the interview, make known to the electors the name of the person or organisation conducting the exit poll and that the exit poll is not commissioned by the Government;
- not to collect or retain any personal data (such as name and Hong Kong Identity Card number) relating to the identity of the electors;
- > not to stay, loiter or accost electors in the areas designated as the No Staying Zone;
- not to speak to or otherwise communicate with candidates or their agents when conducting the poll outside polling station(s); and
- not to canvass electors in the No Canvassing Zone or carry out any activities that will give rise to any suspicion that they are canvassing electors inside the No Canvassing Zone (please refer to Chapter 14 of the Guidelines).

Please state on the envelope "Rural By-election - Application Form for Conduct of Exit Poll". If applicants / applicant organisations fail to provide accurate data as requested in this Application Form 10 days before the polling day, or applicants/ applicant organization fail to provide the additional information as requested by the HAD (if any) by the specified date, their applications to conduct an exit poll **may not be processed**.

- 5. 在考慮票站調查申請時,民政事務總署或會要求申請人/申請機構提供補充資料。如申請人 /申請機構在指定日期之前未能提供所需的資料,其票站調查之申請可能不予受理。
 - In considering the application to conduct an exit poll, the HAD may request additional information from the applicants/ applicant organisations. If applicants / applicant organisations fail to provide the requested information by the specified date, their applications to conduct an exit poll may not be processed.

- (b) any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.

their contact telephone numbers will be released prior to the polling day for reference by the public and candidates. Such a list will also be displayed at the respective polling stations. All the identity document numbers and the declarants' addresses will be covered up before the lists are displayed.

(b) <u>Transfer of Information</u>

The personal data and other related information supplied in connection with this Application Form may be provided to the relevant law enforcement agencies, other authorised departments or persons, including but not limited to the courts for election-related purposes.

(c) Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) Personal Data Protection Principles

Please note that applicants must observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this Application Form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that the personal data are protected against unauthorised or accidental access, processing and use.

(e) Enquiry
