# Notes on Completion of Nomination Form for the Rural By-election (Resident Representative)

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation, including the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L).

An nomination form must be <u>subscribed and signed personally by at least 5 subscribers</u>. All the <u>subscribers must be registered electors for the relevant Existing Village</u>. A candidate should not sign as a subscriber in his/her nomination form. To avoid the risk of invalidation of the nomination if any subscriber is unqualified, the nomination form may be subscribed by more than 5 subscribers. If there are more than 10 subscribers, the "Supplementary Sheet for Subscribers" must be used. Each sheet of "Supplementary Sheet for Subscribers" should be marked with a consecutive serial number starting with "Supplementary Sheet (1)". All pages (including all sheets of "Supplementary Sheet for Subscribers") of the form must be returned to the Returning Officer in one complete set. A candidate should check the qualification of the subscribers. If for any reason a subscriber is

found to be unqualified to subscribe to the nomination form, his/her subscription will be disregarded. A candidate should also remind each subscriber to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register of the relevant Village).

- 5. 每一位有關現有鄉村的登記選民只可就其所屬的鄉村以提名人身分簽署<u>一份</u>提名表格。 A registered elector in respect of the relevant Existing Village is entitled to subscribe only **ONE** nomination form regarding his/her own Village.

Please provide the name and principal residential address of the candidate in both Chinese and English for publication of the Notice of Valid Nominations in the Government Gazette. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register of the relevant Village, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name as shown on his/her identity document in Traditional Chinese or Simplified Chinese (as the case may be). Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name(s) (including alias(es)) of the candidate(s) as shown in the Notice of Valid Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the principal residential addresses of the person/candidate(s) concerned as given on their nomination forms.

A nomination form must be handed in by the candidate <u>in person</u> (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from <u>29 October 2019 to 11 November 2019</u> (both days inclusive) during ordinary business hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday. According to section 2A(3) of the Electoral Procedure (Rural Representative Election) Regulation (Cap.

541L), if the last day of the nomination period falls on an inclement weather warning day (a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap.62)), the period is extended to end on the next working day which is not an inclement weather warning day.

The Returning Officer's decision on the validity of a nomination cannot be questioned in any proceeding except by an election petition.

  - A nomination will not be valid unless the nomination form contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L). The Returning Officer concerned may request such additional information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.

  - A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election in this Rural By-election. When he/she submits his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any. Otherwise, his/her subsequent nomination(s) will be treated as invalid.

- (d) on the date of nomination, or of the election, is serving a sentence of imprisonment;

- (4) A person is disqualified from being elected as a Resident Representative for an Existing Village if, at any time after the close of nominations of candidates for election for the Village, the person ceases to be a resident of the Village.
