## Personal Information Collection Statement

### Purpose of Collection

Any person who uses the personal data provided in this declaration without the express consent of the data subject for any purpose other than the purposes stated above may contravene the Personal Data (Privacy) Ordinance (Cap. 486).

### Transfer of Information

Where necessary, the information provided by you may also be provided to other authorized departments/organisations/persons for the purposes of voter registration under relevant Ordinances and/or subsidiary legislations and all purposes related thereto.

### Access to Personal Data and Enquiry

You have a right to request access to, and to request the correction of, the personal data and other related information you supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486). Such requests and enquiries should be made in writing to the Electoral Registration Officer at 30th Floor, Southorn Center, 130 Hennessy Road, Wan Chai, Hong Kong.
