Notes on Completion of Notification of Corrected Information in Relation to Election Advertisements

Any notification of corrected information so deposited will be used together with the "Information Sheet in Relation to Election Advertisements" referred to in paragraph 1 of page 1 of this form as one of the bases for examining and checking the "Return and Declaration of Election Expenses and Election Donations" (form no.: HAD/C1/By-E) of the candidate.
