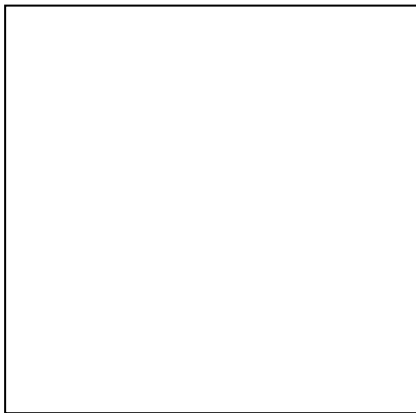

Access to Personal Data
