  - a notice of appointment is given at least 7 days before polling day and delivered to the Director of Home Affairs by hand, by post, by electronic mail or by facsimile transmission; and
- (b) 懲教署署長同意該項委任。 (2009年第134號法律公告; 2014年第12號第48條) the Commissioner of Correctional Services consents to the appointment. (L.N. 134 of 2009; 12 of 2014 s. 48)

The Commissioner of Correctional Services must not give consent under subsection (1A) if he has given consent under section 22(3)(h) to the election agent of the same candidate. (L.N. 134 of 2009)

  - Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a polling agent. A person can be appointed as a polling agent for more than one polling station. A candidate or his election agent should not appoint as his polling agent any Returning Officer, Assistant Returning Officer, or any person (usually a Government officer) already appointed by the Returning Officer/Home Affairs Department to assist at the poll or the count

- (4) (a) 候選人及其選舉代理人或監察投票代理人不得同時逗留在投票站內。
  A candidate and his election agent or polling agent shall not be present at the same time in the polling station.
  - (b) 投票站主任會規管可進入投票站的候選人、選舉代理人或監察投票代理人的數目。如可容納該等人士的指定範圍已滿座,投票站主任可拒絕其他人士進入投票站。

The admission into the polling station of a candidate, his election agent or polling agent is subject to the overriding power of the Presiding Officer to regulate the number of persons admitted to the polling station. If the full capacity of the area inside the polling station designated for such persons has been reached, the Presiding Officer will refuse further admission.

- (c) 進入投票站的指定範圍是採用先到先得的方法。假若在同一時間內要求進入指定範圍的人數超額,將以抽籤決定進入的先後次序。
  - Admission to the designated area of the polling station will be on a first-come-first-served basis. If the number of persons seeking admission at the same time exceeds the capacity, then lots will be drawn.
- (d) 獲准進入指定範圍的人士,只可在指定範圍內逗留一小時;除非在指定範圍內的人數並未滿額,亦無其他人士在輪候進入該範圍,否則一小時後他必須離開。每位進入投票站指定範圍的人士須在簽到冊簽到並記錄進入時間。

A person will only be allowed to stay in the designated area for ONE HOUR, thereafter he must leave unless the designated area is not fully occupied and no other person is waiting to be admitted. Every person admitted to the polling station is required to sign in and enter the time on the log book kept by the polling staff.

- (e) 當指定範圍所能容納的人數額滿時,輪候的每位人士會獲發一個號碼卡,以記錄指定範圍有空位時他獲准入內的次序。當輪到持有某一號碼卡的人士進入該範圍時,投票站人員會在投票站入口宣布該號碼。如該號碼持有人當時並不在場,則持有下一個號碼的人士會被獲准進入指定範圍。當缺席的人士再次回到投票站外時,便須重新領取另一號碼輪候。
  - When the designated area is full, each person waiting to be admitted will be issued a number chit in sequence to record the order of his entry to the designated area when a vacant seat arises. When it is his turn, his number will be called outside the entrance to the polling station, but if he is not present, then his place will be given to the one holding the next number. Such an absentee will have to obtain another number chit and join the queue afresh on his return.

- (8) 通知書/申請書須於投票日前的第7天或之前,藉專人送遞、郵遞、電子郵件或圖文傳真方式,交付 予有關選舉主任。

The notice / application shall be delivered to the Returning Officer by hand, by post, by electronic mail or by facsimile transmission at least 7 days before polling day.

- (9) 選舉主任收到本通知書/申請書後,會向申請人發出一份確認收件通知,你可根據收件通知書上的申請編號,於鄉郊代表選舉網頁 www.had.gov.hk/rre 查閱申請是否獲得批准。如懲教署署長拒絕給予代理人進入專用投票站,有關結果將會通知申請人。
  - The applicant will receive an acknowledgement receipt from the Returning Officer after submission of this application form. You may use the application number as stated in the acknowledgment receipt to check the application result in the HAD website "www.had.gov.hk/rre". The applicant will only be notified if the Commissioner of Correctional Services refuses to give consent to the agent(s) to enter the dedicated polling station.
