## 填寫撤銷授權招致選舉開支通知書說明

### Notes on Completion of Notice of Revocation of Authorization to Incur Election Expenses

1. 有關招致選舉開支的授權書除非在有關的選舉期間結束前被撤銷，否則該等授權書持續有效，直至有關的選期間結束為止。如要撤銷授權，作出該項授權的候選人須藉專人送遞或以郵遞或圖文傳真方式，把撤銷授權招致選舉開支通知書送交有關的選舉主任或（如未委任選舉主任）有關的民政事務總署署長。

An authorization to incur election expenses remains in force until the end of the relevant election period unless it is revoked earlier. If an authorization is to be revoked, the candidate who made the authorization must give a Notice of Revocation of Authorization to Incur Election Expenses to the relevant Returning Officer, or if the Returning Officer has not been appointed, to the relevant Director of Home Affairs by hand, or sent by post or by facsimile transmission.

2. 撤銷授權招致選舉開支通知書只有在有關的選舉主任或（如未委任選舉主任）有關的民政事務總署署長收到撤銷通知後方生效。

The revocation of authorization to incur election expenses will not be effective until the relevant notice is received by the relevant Returning Officer, or the relevant Director of Home Affairs if the Returning Officer has not been appointed.

3. 根據《鄉郊代表選舉條例》（第 576 章）第 2(1)條，“身分證明文件”（identity document）指 –  
According to section 2(1) of the Rural Representative Election Ordinance (Cap. 576), “identity document”（身分證明文件）means –

- (a) 身分證；或

an identity card; or

- (b) 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。

any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.

4. 候選人應將通知書的副本交予被撤銷授權的人士。

A copy of the notice should be sent to the person whose authorization has been revoked.

6. 請注意下列有關在此通知書提供個人資料的說明 –

Please note the following with regard to the personal data supplied in connection with this notice-

- (a) **資料用途**

就此通知書提供的個人及其他有關的資料，會供民政事務總署及選舉主任用於與選舉有關的用途。

#### **Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Home Affairs Department and the Returning Officer for election-related purposes.

- (b) **資料轉介**

此通知書將根據《選舉程序（鄉郊代表選舉）規例》（第 541 章，附屬法例 L）提供給公眾查閱。在展示前，通知書內所有身分證明文件號碼將會被遮蓋。有關此通知書內的資料可能會提供予其他獲授權的部門／機構／人士，包括（但不限於）法院，用於與選舉有關的用途。

The notice will be made available for public inspection in accordance with the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L). All identity document numbers in the notice will be covered before display. The information concerned may also be provided to other authorized departments/organizations/persons including but not limited to the law courts for election-related purposes.

- (c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他所提供的個人資料。

#### **Access to Personal Data**

A person has the right to request access to and correction of the personal data he supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

- (d) **保障個人資料原則**

請注意，候選人在收集第三者的個人資料以填寫有關表格時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的資料保障原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

**Personal Data Protection Principle**

The candidate is reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in completing the relevant form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access and processing.

(e) **查詢**
